6 AN ORDINANCE APPROPRIATING \$91,240.00 FROM  
7 AVAILABLE REVENUE BALANCE IN THE DOMESTIC  
8 BATTERY SURCHARGE TRUST FUND (THE "FUND") TO  
9 ESTABLISH THE FISCAL YEAR 2022-2023 OPERATING  
10 BUDGET FOR THE FUND AND TO PROVIDE ADDITIONAL  
11 TRAINING TO LAW ENFORCEMENT PERSONNEL IN  
12 COMBATING DOMESTIC VIOLENCE, AS INITIATED BY  
13 B.T. 23-011; PROVIDING AN EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Appropriation.** For the 2022-2023 fiscal year,  
17 within the City's budget, there is hereby appropriated the indicated  
18 sum(s) from the account(s) listed in subsection (a) to the account(s)  
19 listed in subsection (b):

27 The funding above is an appropriation of available revenue  
28 from County Court fines and investment pool earnings in  
29 the Domestic Battery Surcharge Trust Fund (the "Fund") to  
30 establish the fiscal year 2022-2023 operating budget for  
31 the Fund.

1           **Section 2.           Purpose.**   The purpose of the appropriation in  
2 Section 1 is to establish the fiscal year 2022-2023 operating budget  
3 for the Domestic Battery Surcharge Trust Fund.   The funds will be  
4 used to provide additional training to law enforcement personnel in  
5 combating domestic violence.   There are no requirements for a local  
6 match, nor will there be additional staffing obligations or ongoing  
7 maintenance costs associated with this appropriation.

8           **Section 3.           Effective Date.**   This Ordinance shall become  
9 effective upon signature by the Mayor or upon becoming effective  
10 without the Mayor's signature.
