COUNCIL RULE 4.505 DISRUPTION OF MEETING

Any person who disrupts a regular meeting of the City Council, standing committees, special or select committees, sub-committees or any other public meeting presided over by a City Council Member may be forthwith barred, removed, or otherwise ejected, in the discretion of the presiding officer, from further attendance at that meeting. If necessary, due to the nature of the disruption, the audience may be cleared from the Council Chambers or meeting location in the discretion of the presiding officer.

Any person who refuses to leave the City Council Chamber may be subject to arrest.

Disruption of a meeting includes the following types of behaviors:

- 1) Any form of political campaigning or electioneering regarding a specific candidate or group of candidates in City elections;**
- 2) Impeding the orderly progress of the meeting by shouting, yelling, whistling, chanting, singing, dancing, clapping, foot stomping, snapping fingers, cheering, jeering, using artificial noise makers or musical instruments, waving signs of any size, or engaging in any other display of excessive noise, sounds, or movement;**
- 3) Displaying or waving signs of any sort, except where used to support the speaker's presentation at the podium, and only where the sign is 21 inches by 21 inches or smaller in size and cannot be displayed in a manner which unreasonably obstructs the view of the dais for any member of the audience, regardless of message;**
- 4) Audible noise from cellphones or other electronic devices;**
- 5) Consumption of alcohol or controlled substances;**
- 6) Making vulgar or offensive remarks or gestures, or using threatening language or gestures, including but not limited to pantomiming discharging a firearm, choking, or throat-cutting;**
- 7) Refusing to stop speaking when his or her time has expired or is otherwise directed by the presiding officer to do so due to disruptive behavior as described herein;**
- 8) Returning to the meeting after having been removed or ejected, or attempting to do so.**

Presentation by Employee Services Department

Ms. Hayes of Employee Services presented an overview of the appointed official hiring process. She explained that appointed officials are full-time, at-will employees appointed by the Mayor and confirmed by Council, receiving benefits similar to civil service but not under civil service rules. Positions may be filled without posting; if posted, Employee Services updates job descriptions, prepares postings, and screens applicants. Applications are evaluated using supplemental questions, degree verification, veterans’ preference, and structured interviews emphasizing core competencies such as business acumen and emotional intelligence. Panels include senior leadership, HR, and subject matter experts. Tools like matrices are used to summarize candidates. Interviews focus on behavioral and situational questions. Following interviews, panels debrief and rank candidates. Ms. Hayes noted that the City does not use scoring for executive hires, emphasizing the importance of assessing qualitative skills.

Chair Miller thanked Ms. Hayes, noting that the process lacks objective scoring measures, which in his view may reduce fairness compared to systems using scoring matrices. He referenced morale issues with JFRD’s current scoring system as an example.

Council Member Amaro asked how the City’s process compares to the private sector. Ms. Hayes responded that practices vary; some agencies sometimes use scoring, while others do not. She stressed the importance of consistency and confirmed satisfaction with current procedures, emphasizing due diligence and broad eligibility requirements.

Council Member Freeman asked if the legislation was tied to the ongoing lawsuit or other issues related to the Laura Street Trio, noting that Live Oak was no longer part of that project.

Mr. Peterson responded that the bill was not tied to the lawsuit but was introduced by then-Council President Carrico to address administrative and nuisance fines on the property. He confirmed he had also heard that Live Oak was no longer involved but had not spoken to the Council President since that development.

Council Member Freeman added that Live Oak had recently won the RFP for JEA and questioned whether this legislation remained necessary. He suggested reaching out to the Council President's office to see if the bill should continue to be deferred, noting that it had been pending since November 2024.

There was a motion and second to withdraw. Council Member Gaffney, Jr. explained that NCI, the intended recipient, remains on the noncompliance list but expects to resolve the issues within 30 60 days. He asked that the bill be amended rather than withdrawn so funds could be released once compliance is met.

Chair Miller requested clarification. Mr. Peterson outlined an amendment providing NCI until November 15 to come into compliance with funds reverting to reserves if the deadline is not met.

Council Member Boylan asked about procedure, Ms. Lopera explained the proper procedure. Council Member Freeman moved the withdrawal.

Mr. Peterson noted additional technical amendments required by the Grants Division, including regrant agreements, scoring rubrics, and approval of scoring members. Council Member Freeman expressed concern that another committee had already acted on withdrawal earlier in the day, and now the action was being reversed without giving that committee the same updated information. He said he might have to vote no without more time to review but wanted to support the intent.

Council Member Gaffney, Jr., responded that the idea for the amendment came from earlier committee discussions, and after speaking with NCI directly, he was confident compliance would be achieved within 30-60 days. He confirmed that NCI was present and prepared to answer questions.

Council Member Freeman said his concerns had been addressed, noting that the other committee members involved in the earlier action were present, and he was willing to move forward.

Council Member Boylan moved the auditor's amendment, and it was seconded. The auditor's amendment was passed via a voice vote.

Mr. Peterson outlined the auditor's amendment, which revised Exhibit 2 to require executed regrant agreements, copies of scoring rubrics, and approval of scoring committee members to ensure they were not on the noncompliance list.

Council Member Boylan moved the amendment, and it was seconded. The amendment was passed via a voice vote.

Both amendments were rolled together, and the bill as amended was approved.

Ms. Carraher explained the NCSPHS amendment. Council Member Salem stated that the Mayor's Council on Fitness and Well-Being has not met since the COVID-19 pandemic and expressed concern over confusion regarding whether a consultant would be hired. He said he did not believe the bill was ready and would vote no.

Council Member Freeman noted he had served as liaison to the council, which met via Zoom during COVID. While he appreciated the members, he questioned the clarity of its mission and asked the bill sponsor to provide an update on the council's current role and use of funds.

The amendment passed via a hand vote, with Council Members Salem and Gay opposing.

Council Member Johnson thanked Freeman and clarified that no consultant was ever requested, noting that confusion arose from drafting. Phillip Peterson, Council Auditor's Office confirmed this and apologized for the misstatement. Council Member Johnson said he was appointed liaison to the board, researched its history, and developed a plan to reactivate it. He explained the funds would support strategic initiatives in health, screenings, and community programs, and emphasized these are not "cookie jar" dollars but intended for public purpose. He noted he reduced his request from \$51,000 to \$31,000 after reallocations.

Council Member Freeman said he would remain consistent in supporting use of strategic dollars but expressed concern about funds being used for other agencies without council oversight. He asked how councils like this receive funding from the administration.

Mr. Peterson explained that no dedicated funds are provided in the mayor's budget; the dollars came from council's strategic initiatives, which were reduced across the board to 76% of requests. Council Member Johnson is seeking to move his allocation above the line for this purpose.

Council Member Freeman urged colleagues to use remaining funds in the current cycle and asked Council Member Johnson to report back on how the dollars are spent. Council Member Johnson confirmed all his initiatives include reporting requirements.

Chair Miller said his concern was not knowing specifically how the dollars would be used. While reassured that no consultant was planned, he remained cautious about funding additional strategic plans when the administration already has planners.

Mr. Peterson advised amending the bill language, noting it currently referenced a consultant, which does not reflect Council Member Johnson's intent and confirmed that would be the most transparent course.

Council Member Boylan said he would offer the amendment if Council Member Johnson clarified the purpose of the funds.

Council Member Johnson explained the funds would support community health and wellness events, screenings, and related initiatives. He noted this aligns with council's strategic priorities and that supporting documents had been provided to staff.

Ms. Lopera restated the amendment for clarification.

Council Member Boylan moved the amendment, which was seconded by Council Member Amaro.

Council Member Freeman expressed concern that the amendment shifted the bill from supporting a standing council to funding events. He questioned whether this aligned with his earlier support for strategic initiatives.

Council Member Johnson responded that the funds would support a public awareness campaign, branding, media outreach, screenings, and wellness events, not just event planning.

Chair Miller asked about timing, noting the lack of clarity before introduction. Mr. Peterson advised the dollars lapse on September 30 unless carried forward. He noted Council could place the funds in contingency for the board and re-appropriate next year with a plan.

Chair Miller supported that option and asked colleagues how to proceed. Council Member Boylan withdrew his amendment.

Council Member Freeman asked about continuity if Council Member Johnson is no longer liaison. Council Member Johnson replied his plan only sets a foundation, and leadership would transition once the board reactivates.

Council Member Salem reiterated his opposition, suggesting the bill be voted down and funds revert to reserves, with the possibility of re-appropriating for an active board in the future.

Chair Miller asked staff to clarify posture. Ms. Lopera stated the bill remained as amended by NCSPHS, reducing the appropriation to \$31,227.

Council Member Amaro said he supports colleagues' initiatives but noted the board has been inactive, and he was not convinced \$31,000 would revitalize it.

Council Member Freeman stated that once the \$77,953 balance is approved, council will no longer control how the funds are spent. He questioned whether the money could be used for salaries and noted that the answer was no. He suggested it might be useful to ask the Council President or colleagues if there were plans for the funds, as he was left uncertain about their future use.

Council Member Amaro asked if this appropriation was part of the \$100,000 previously approved by council. Mr. Peterson confirmed, explaining that approximately \$22,000 had been spent with the Ballard Spahr law firm for review of the Laura Street Trio agreements in 2024. The remaining \$77,953 is the balance.

Council Member Amaro further asked if legislation was necessary to make this appropriation.

Mr. Peterson replied that the full \$100,000 was originally appropriated and carried forward until September 30 of this year. He added that the Personnel Committee had discussed carrying the remaining balance over into FY 2025-26 to cover future costs of legislative counsel for the City Council.
