14 INTRODUCTION; PROVIDING FOR CITY OVERSIGHT BY
15 THE FINANCE AND ADMINISTRATION DEPARTMENT AND
16 THE JACKSONVILLE FIRE AND RESCUE DEPARTMENT;

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
21 within the City's budget, there are hereby appropriated the
22 indicated sum(s) from the account(s) listed in subsection (a) to

30 (c) Explanation of Appropriation

31 Ordinance 2019-852-E authorized the City to enter into an

1 agreement (the "Agreement") with the State of Florida
2 Agency for Health Care Administration ("AHCA") to provide
3 funding to the Jacksonville Fire and Rescue Department
4 for public emergency medical transportation needs. The
5 appropriation authorized herein provides the required
6 funding for the Agreement.

7 **Section 2. Purpose.** The purpose of the appropriation in
8 Section 1 is to provide the funding required for the Agreement.

9 **Section 3. Emergency Passage Upon Introduction Pursuant**
10 **to Council Rule 4.901 Emergency.** Emergency passage upon
11 introduction of this legislation is requested. The nature of the
12 emergency is that the City must transfer the funds to AHCA within a
13 time certain and will lose eligibility for matching State funds if
14 the City does not timely forward the City funds to AHCA pursuant to
15 the Agreement.

16 **Section 4. Oversight Department.** The Finance and
17 Administration Department and Jacksonville Fire and Rescue
18 Department shall oversee the project described herein.

19 **Section 5. Effective Date.** This ordinance shall become
20 effective upon signature by the Mayor or upon becoming effective
21 without the Mayor's signature.
