(c) Explanation of Appropriation:

The funding above represents an appropriation of grant funds in the amount of \$50,000.00 from the State of Florida, Department of State, Division of Historical Resources to the Cemetery Maintenance Trust for the purpose of protecting and restoring Sunset Memorial Cemetery (the "Project").
