AN ORDINANCE REGARDING MEMBER APPOINTMENTS TO CERTAIN COMMUNITY REDEVELOPMENT AGENCY ADVISORY BOARDS OF THE CITY OF JACKSONVILLE; AMENDING SECTION 53.102 (MEMBERSHIP; APPOINTMENT AND REMOVAL; TERMS OF OFFICE), PART 1 (RENEW ARLINGTON COMMUNITY REDEVELOPMENT AGENCY ADVISORY BOARD), CHAPTER 53 (COMMUNITY REDEVELOPMENT AGENCY ADVISORY BOARDS), ORDINANCE CODE, TO EXPAND THE GEOGRAPHIC BOUNDARIES FOR CERTAIN MEMBER CATEGORIES; AMENDING SECTION 53.202 (MEMBERSHIP; APPOINTMENT AND REMOVAL; TERMS OF OFFICE), PART 2 (KINGSOUTEL CROSSING COMMUNITY REDEVELOPMENT AGENCY ADVISORY BOARD), CHAPTER 53 (COMMUNITY REDEVELOPMENT AGENCY ADVISORY BOARDS), ORDINANCE CODE, TO BROADEN THE GEOGRAPHIC AND CATEGORICAL REQUIREMENTS FOR CITIZEN MEMBERS REPRESENTING THE GENERAL PUBLIC; PROVIDING FOR CODIFICATION INSTRUCTIONS; PROVIDING AN EFFECTIVE DATE.
