7 APPROPRIATING \$2,941,196 FROM A DESIGNATED
8 SPECIAL COUNCIL CONTINGENCY ACCOUNT FOR PUBLIC
9 SERVICE GRANTS; PROVIDING FOR CITY OVERSIGHT BY
10 THE OFFICE OF GRANTS AND CONTRACT COMPLIANCE OF
11 THE DEPARTMENT OF FINANCE AND ADMINISTRATION;
12 WAIVING THE CONFLICTING PROVISION OF §118.802
13 (ANNUAL LUMP SUM APPROPRIATION FOR PUBLIC
14 SERVICE GRANTS), *ORDINANCE CODE*, DUE TO THE
15 NEED FOR SEPARATE LEGISLATION FROM THE ANNUAL
16 BUDGET ORDINANCE TO APPROVE THE LUMP SUM
17 APPROPRIATION FOR PUBLIC SERVICE GRANTS;
18 PROVIDING AN EFFECTIVE DATE.

20 **BE IT ORDAINED** by the Council of the City of Jacksonville:

21 **Section 1. Appropriation.** For the 2020-2021 fiscal year,
22 within the City's budget, there are hereby appropriated the
23 indicated sum(s) from the account(s) listed in subsection (a) to
24 the account(s) listed in subsection (b):

1 (c) **Explanation of Appropriation** - The funding above is being
2 appropriated from the designated Council Contingency
3 account for Public Service Grants.

4 **Section 2. Purpose.** The Public Service Grant
5 appropriation made in **Revised Exhibit 2**, labeled as "Revised
6 Exhibit 2, Rev Schedule, September 15, 2020 - Finance" shall be
7 used only for the purpose of the listed Public Service Grant
8 Appropriations and may not be transferred or reallocated for any
9 other utilization within the respective department. Public Service
10 Grants are subject to the provisions of Chapter 118, Ordinance
11 Code. The appropriations made herein shall be awarded as grants-in-
12 aid to the miscellaneous agencies, and shall not require additional
13 legislation for distribution of funds. Pursuant to Section 118.808,
14 *Ordinance Code*, the Public Service Grant Council shall forward a
15 complete list of the Public Service Grants recipients and funding
16 allocation to the Council Auditor's office, the Office of the
17 Mayor, the City Council and the Director of the Finance and
18 Administration Department.

19 **Section 3. Oversight Department.** The Office of Grants and
20 Contract Compliance of the Finance and Administration Department
21 shall oversee the project described herein.

22 **Section 4. Waiving conflicting provision of §118.802**
23 **(Annual Lump Sum Appropriation for Public Service Grants),**
24 **Ordinance Code.** The conflicting provision of §118.802 (Annual Lump
25 Sum Appropriation for Public Service Grants), *Ordinance Code*,
26 referring to "the annual budget ordinance" is hereby waived. Waiver
27 of Section 118.802, *Ordinance Code*, is necessary because the Public
28 Service Grant lump sum appropriation for the 2020-2021 annual
29 budget will be considered by Council not in the annual budget
30 Ordinance 2020-504, but rather in a separate Ordinance 2020-509.

31 **Section 5. Effective Date.** This ordinance shall become

1 effective upon signature by the Mayor or upon becoming effective
2 without the Mayor's signature.
