KHA is seeking City Council approval to authorize a six month extension to an existing lease agreement with Lutheran Services Florida (LSF). LSF leases office space within the KHA building located at 1095 A. Philip Randolph Boulevard and their current lease with KHA is set to expire on December 31, 2024. The extension will extend the agreement through June 30, 2025. KHA is requesting a six month extension to align the contract cycle with other KHA leases. A one-cycle emergency is being requested as the lease expires on December 31, 2024 and legislation must be approved by KHA's Board prior to filing. The KHA Board meeting takes place on November 20, 2024.


