5 AN ORDINANCE CONFIRMING THE MAYOR'S APPOINTMENT  
6 OF WILFRED A. WILLIAMS AS OPERATIONS DIRECTOR OF  
7 THE CITY OF JACKSONVILLE PURSUANT TO SECTION  
8 32.104 (OPERATIONS DIRECTOR), PART 1 (IN  
9 GENERAL), CHAPTER 32 (PUBLIC WORKS DEPARTMENT),  
10 *ORDINANCE CODE*; WAIVING THE REQUIREMENT OF  
11 SECTION 32.104 (OPERATIONS DIRECTOR), PART 1 (IN  
12 GENERAL), CHAPTER 32 (PUBLIC WORKS DEPARTMENT),  
13 *ORDINANCE CODE*, THAT THE OPERATIONS DIRECTOR BE  
14 REGISTERED BY THE STATE OF FLORIDA AS A  
15 PROFESSIONAL ENGINEER; PROVIDING AN EFFECTIVE  
16 DATE.

18 **BE IT RESOLVED** by the Council of the City of Jacksonville:

19 **Section 1. Appointment.** The Council hereby confirms the  
20 Mayor's appointment of Wilfred A. Williams as Operations Director of  
21 the City of Jacksonville pursuant to Section 32.104 (Operations  
22 Director), Part 1 (In General), Chapter 32 (Public Works Department).  
23 Attached hereto as **Exhibit 1** is the *curriculum vitae* of Wilfred A.  
24 Williams.

25 **Section 2. Waiver of Requirement in Section 32.104**  
26 **(Operations Director), Part 1 (In General), Chapter 32 (Public Works**  
27 **Department), Ordinance Code.** The requirement delineated in Section  
28 32.104 (Operations Director), Part 1 (In General), Chapter 32 (Public  
29 Works Department), *Ordinance Code*, that the Operations Director be  
30 registered by the State of Florida as a professional engineer is  
31 hereby waived recognizing that although Mr. Williams is not registered

1 by the State of Florida as a professional engineer, he does possess  
2 a master's degree in Business Administration and has over six (6)  
3 years of experience as the City's Chief of Solid Waste Division.

4 **Section 3. Effective Date.** This ordinance shall become  
5 effective upon signature by the Mayor or upon becoming effective  
6 without the Mayor's signature.
