2 Kids Book Club as part of the Jacksonville Public Library's
3 Story Journeys Literacy Enrichment Summer Program.

4 **Section 2. Purpose.** The purpose of the appropriation in
5 Section 1 is to transfer funds to the Board of Library Trustees Trust
6 Fund for administration of the Jax Kids Book Club which provides
7 books to children aged four years old residing in Duval County. These
8 services are offered in conjunction with the Story Journeys Literacy
9 Enrichment Summer Program which is designed to supplement current
10 summer camp programming.

11 **Section 3. Effective Date.** This Ordinance shall become
12 effective upon signature by the Mayor or upon becoming effective
13 without the Mayor's signature.
