6 AN ORDINANCE APPROPRIATING \$2,238,565 FROM THE
7 GENERAL FUND GSD PROPERTY TAXES ACCOUNT TO THE
8 GENERAL FUND GSD SPECIALIZED EQUIPMENT ACCOUNT
9 TO PROVIDE FUNDING TO THE SUPERVISOR OF
10 ELECTIONS FOR THE PURCHASE OF SCANNERS AND
11 TABULATORS FOR VARIOUS POLLING LOCATIONS;
12 PROVIDING FOR CARRYOVER OF FUNDS; REQUESTING ONE
13 CYCLE EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE
14 DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Appropriation.** For the 2022-2023 fiscal year,
18 within the City's budget, there are hereby appropriated the indicated
19 sum(s) from the account(s) listed in subsection (a) to the account(s)
20 listed in subsection (b):

27 (c) **Explanation of Appropriation** - The funding above is an
28 appropriation from the General Fund GSD Property Taxes
29 account to the General Fund GSD Specialized Equipment
30 account to provide funding to the Supervisor of Elections
31 for the purchase of scanners and tabulators for various

1 polling locations.

2 **Section 2. Purpose.** The purpose of the appropriation in
3 Section 1 above is to provide funding to the Supervisor of Elections
4 for the purchase of scanners and tabulators for its various polling
5 locations. These new scanners and tabulators will replace equipment
6 that is no longer functional.

7 **Section 3. Carryover.** The funds appropriated by this
8 Ordinance shall not lapse but shall carryover to fiscal year
9 2023-2024.

10 **Section 4. Requesting One Cycle Emergency Passage Pursuant**
11 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this
12 legislation is requested. The nature of the emergency is that the
13 funds appropriated herein are available revenues from fiscal year
14 2022-2023 that must be appropriated by September 30, 2023. This
15 appropriation was recommended by the Finance Committee during its
16 August 17, 2023, budget meeting after receipt of a request from the
17 Supervisor of Elections.

18 **Section 5. Effective Date.** This Ordinance shall become
19 effective upon signature by the Mayor or upon becoming effective
20 without the Mayor's signature.
