## ORDINANCE 2024-873

AN ORDINANCE APPROPRIATING \$75,000 FROM A GENERAL FUND OPERATING CONTINGENCY ACCOUNT TO THE GENERAL FUND OPERATING, SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORG ACCOUNT, TO PROVIDE CITY GRANT FUNDING TO FAMILY NURTURING CENTER OF FLORIDA, INC. ("FNC") FOR THE VISITATION SLIDING SCALE PROGRAM (THE "PROGRAM") AS DESCRIBED HEREIN; INVOKING THE EXEMPTION IN SECTION 126.108(G) (EXEMPTIONS FROM COMPETITIVE SOLICITATION), PART 1 (GENERAL REGULATIONS; ETHICS AND TRANSPARENCY IN PUBLIC CONTRACTING), CHAPTER 126 (PROCUREMENT CODE), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH FNC FOR THE PROGRAM; WAIVING SECTION 118.107 (NONPROFITS TO RECEIVE FUNDING THROUGH A COMPETITIVE EVALUATED AWARD PROCESS), PART 1 (GENERAL PROVISIONS), CHAPTER 118 (CITY GRANTS), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH FAMILY NURTURING CENTER OF FLORIDA, INC.; WAIVING CERTAIN PROVISIONS OF SECTION 118.301 (EXPENDITURE OF APPROPRIATED FUNDS), PART 3 (ADMINISTRATION OF CITY GRANTS), CHAPTER 118 (CITY GRANTS), ORDINANCE CODE, TO ALLOW A PORTION OF THE GRANT FUNDS TO BE EXPENDED FOR COSTS OF AMUSEMENTS, SOCIAL ACTIVITIES, AND INCIDENTAL COSTS RELATING THERETO; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND

THE CORPORATION SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF THE CITY A GRANT AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND FNC FOR THE PROGRAM; PROVIDING FOR OVERSIGHT BY THE GRANTS AND CONTRACT COMPLIANCE DIVISION OF THE FINANCE DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2024-2025 fiscal year, within the City's budget, there is hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) Explanation of Appropriation:

The funding above is an appropriation of \$75,000 from a General Fund Operating Contingency account to the General Fund Operating, Subsidies and Contributions to Private Org account, to provide a grant to Family Nurturing Center of Florida, Inc. ("FNC") for the Visitation Sliding Scale Program (the "Program") as described herein.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide grant funds from the City of Jacksonville to FNC for the Visitation Sliding Scale Program as described in Exhibit 2, attached hereto and incorporated herein by this reference. The Program provides supervised visitations and exchanges for low- and middle-income families with children in need of such services and

assistance. Approximately 60% of FNC's clients earn an annual income of less than \$30,000 and the City funds will help to lower the co-payment required for these supervised services. In addition to helping offset this expense, the City funds will be used for occupancy and office expenses for the Program, including office supplies, insurance, professional fees, uniforms and cleaning supplies. Finally, a portion of the City funds will help offset other direct client expenses including toys, entertainment, snacks and beverages for the children served through the Program and interpretation services and transportation vouchers for the participating families.

Section 3. Invoking the Exemption in Section 126.108(g), Ordinance Code. The City is hereby authorized to directly procure the professional services of Family Nurturing Center of Florida, Inc. for the Program as described herein. Pursuant to Section 126.108(g) (Exemptions from competitive solicitation), Part 1 (General Regulations; Ethics and Transparency in Public Contracting), Chapter 126 (Procurement Code), Ordinance Code, such procurement is exempted from competitive solicitation because the supplies or services are to be provided by those specifically prescribed within authorizing legislation. With the exception of the foregoing, all other provisions of Chapter 126, Ordinance Code, shall remain in full force and effect.

Section 4. Waiver of Section 118.107, Ordinance Code. The provisions of Section 118.107 (Nonprofits to receive funding through a competitive evaluated award process), Part 1 (General Provisions), Chapter 118 (City Grants), Ordinance Code, are hereby waived to allow for a direct contract with FNC. This waiver is justified because FNC provides unique services to low- and middle-income members of the community by overseeing supervised visitations for parents in high-conflict or high-risk situations and by providing supervised exchanges that allow custodial transfer of time from one parent to another in a manner that prevents conflicts or interactions between

the parents.

Section 5. Waiver of Certain Provisions of Section 118.301, Ordinance Code. The provisions of Subsection 118.301(a)(3)(iv) (Expenditure of appropriated funds), Part 3 (Administration of City Grants), Chapter 118 (City Grants), Ordinance Code, are hereby waived to allow for a portion of the grant funds to be expensed for costs of amusements, social activities and incidental costs relating thereto. This waiver is justified as it will allow FNC to make toys and entertainment as well as snacks and treats available for children who are served through the Program. This serves as a simple but integral part in making children comfortable during supervised visitations and exchanges.

Section 6. Approval and Authorization to Execute. There is hereby approved, and the Mayor, or her designee, and the Corporation Secretary are hereby authorized to execute and deliver on behalf of the City a grant agreement with Family Nurturing Center of Florida, Inc. in an amount not-to-exceed \$75,000, subject to the Term Sheet and Budget more particularly described in Exhibit 2, for a term commencing on October 1, 2024 through September 30, 2025, and all other contracts and documents, including extensions, renewals and amendments to the agreement, and to otherwise take all action necessary to effectuate the intent of this Ordinance, subject to appropriate legal review and approval by the General Counsel, or his or her designee, and the City's Risk Management Division for appropriate insurance and indemnification requirements in accordance with Section 128.601, Ordinance Code.

Section 7. Oversight Department. The Grants and Contract Compliance Division of the Finance Department shall oversee the project described herein.

Section 8. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective

without the Mayor's signature.
