A RESOLUTION WELCOMING THE RETURN OF BETHUNE-COOKMAN UNIVERSITY FOOTBALL TO JACKSONVILLE TO FACE SOUTHERN UNIVERSITY AT EVERBANK STADIUM; REQUESTING EMERGENCY PASSAGE UPON INTRODUCTION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, in 2022 the BCU Wildcats returned to Jacksonville after an absence of more than a decade to face Head Coach Deion Sanders' Jackson State Tigers; and

WHEREAS, the Wildcats return to EverBank Stadium again on October 21, 2023, to face the Southern University Jaguars from Baton Rouge, Louisiana, which will mark the first time the two teams have faced off on the gridiron since their last meeting in Jacksonville in 2006; and

WHEREAS, the City of Jacksonville is pleased and proud to again host Bethune-Cookman University and Southern University football and the fans of both teams to our city for an exciting afternoon of football and pageantry that only HBCUs can provide, including an extended halftime show featuring the Bethune-Cookman Marching
