ORDINANCE 85-162-79

AN ORDINANCE CLOSING AND ABANDONING A PORTION OF ALEXIS ROAD BETWEEN BLOCKS 29 AND 30 AS SHOWN ON THE PLAT OF DUVAL CITY RECORDED IN PLAT BOOK 6, PAGE 9, OF THE CURRENT PUBLIC RECORDS OF DUVAL COUNTY, FLORIDA; RESERVING AN EASEMENT TO THE CITY; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Portion of Alexis Road Closed and Abandoned. That portion of Alexis Road lying between Blocks 29 and 30 as shown on the Plat of Duval City recorded in Plat Book 6, page 9 of the current public records of Duval County, Florida is hereby closed, vacated and abandoned as a public road, street, alley, right of way or thoroughfare, subject however to the reservation to the City of a perpetual unobstructed easement for drainage, sewage, utilities, fire, rescue, police and sanitation vehicles, over, under, across and through the entire parcel.

Section 2. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.

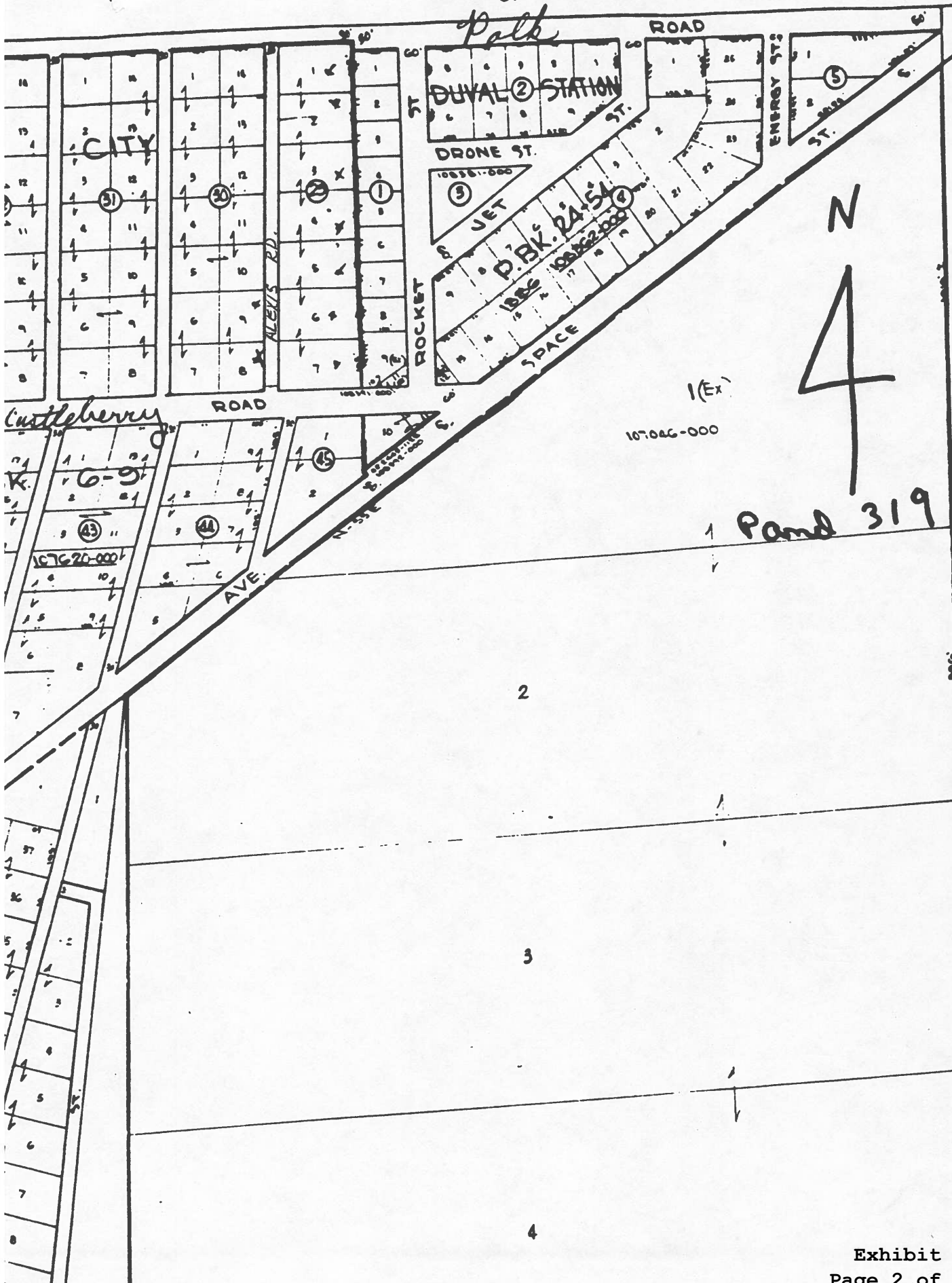
