The Public Works Solid Waste Division is requesting a transfer of \$6,500,000 from the project titled Landfill Gas Fueled Leachate Evaporator to the project titled Trail Ridge Landfill Expansion. The bid price for Trail Ridge Landfill Expansion Unit 7 was higher than the engineer's estimate used for the CIP funding request. As a result, additional funding is necessary for Trail Ridge Expansion Disposal Unit 7, including additional access roads construction, necessary facility improvements, and regulatory certification. Deferral of this amendment until the next CIP would be detrimental to the City as it would result in the unnecessary delay of project completion.
