4 **RESOLUTION 2021-161-A**

5 A RESOLUTION CONFIRMING THE REAPPOINTMENT OF
6 GERALDINE (LOCKETT) JACKSON AS A JEA
7 REPRESENTATIVE TO THE CIVIL SERVICE BOARD OF
8 THE CITY OF JACKSONVILLE, PURSUANT TO SECTION
9 17.02 OF THE CHARTER OF JACKSONVILLE, FOR A
10 FIRST FULL TERM TO EXPIRE JUNE 30, 2023;
11 PROVIDING AN EFFECTIVE DATE.

13 **WHEREAS**, the Legislature of the State of Florida has enacted
14 chapter 2004-437, Laws of Florida, pursuant to which Sections
15 17.02, 17.10, and 17.12 of the Charter of the City of Jacksonville,
16 as created by chapter 92-341, Laws of Florida, as amended, were
17 amended to revise the membership of the Civil Service Board of the
18 City of Jacksonville; and

19 **WHEREAS**, Section 17.02(b), as amended, of the Charter of the
20 City of Jacksonville, Laws of Florida, requires JEA to appoint two
21 members to the Civil Service Board; and

22 **WHEREAS**, Resolution 2019-58-A confirmed the appointment of
23 Geraldine (Lockett) Jackson as a JEA representative for a partial
24 term to expire June 30, 2020; and

25 **WHEREAS**, the JEA Board approved the reappointment of Geraldine
26 (Lockett) Jackson to the Civil Service Board by resolution on
27 January 28, 2021, a copy of the JEA resolution is attached hereto
28 as **Exhibit 1**; and

29 **WHEREAS**, pursuant to Section 17.02(b), as amended, of the
30 Charter of the City of Jacksonville, Laws of Florida, appointments
31 to the Civil Service Board are required to be approved by the City

1 Council; now therefore

2 **BE IT RESOLVED** by the Council of the City of Jacksonville:

3 **Section 1. Confirmation of Reappointment.** The Council does
4 hereby confirm and approve the reappointment of Geraldine (Lockett)
5 Jackson, a Duval County resident, as a JEA representative to the
6 Civil Service Board of the City of Jacksonville, pursuant to
7 Section 17.02 of the Charter of the City of Jacksonville, for a
8 first full term to expire June 30, 2023. Attached hereto as **Exhibit**
9 **2** is the *curriculum vitae* of Geraldine (Lockett) Jackson.

10 **Section 2. Effective Date.** This resolution shall become
11 effective upon signature by the Mayor or upon becoming effective
12 without the Mayor's signature.
