## ORDINANCE 2021-184

APPROPRIATING \$731,500.00 ΑN ORDINANCE (\$397,794.73 FROM SPECIAL EVENTS - FLORIDA GEORGIA GAME CONTINGENCY, \$95,000.00 FROM TERRY PARKER POOL FUND, AND \$238,705.27 FROM COUNCIL DISTRICT 1 AUTUMN BOND FUNDS) TO PROVIDE FUNDING FOR A NEW ARTIFICIAL TURF FIELD AT BLUE CYPRESS PARK, LOCATED IN COUNCIL DISTRICT 1; APPROVING AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND CORPORATION SECRETARY TO EXECUTE AND DELIVER, AN AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND RECREATION, INC.; INVOKING THE SOUTHERN EXCEPTION IN SECTION 126.107 (G), ORDINANCE CODE, ALLOW DIRECT CONTRACT WITH SOUTHERN TΟ RECREATION, INC. TO PROVIDE PURCHASE INSTALLATION OF NEW ARTIFICIAL TURF FIELD AT BLUE CYPRESS PARK; PROVIDING FOR REVERTER OF FUNDS; PROVIDING FOR THE OVERSIGHT BY THE PARKS, RECREATION AND COMMUNITY SERVICES DEPARTMENT; THE 2021-2025 FIVE-YEAR AMENDING CAPITAL IMPROVEMENT PROGRAM APPROVED BY ORDINANCE 2020-505-E TO AUTHORIZE THE PROJECT TITLED "BLUE CYPRESS PARK SOCCER FIELD"; REQUESTING ONE CYCLE EMERGENCY ACTION; PROVIDING AN EFFECTIVE DATE.

**BE IT ORDAINED** by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2020-2021 fiscal year, within the City's budget, there are hereby appropriated the indicated

## (C) Explanation of Appropriation

\$397.794.73 of funds above are being appropriated from Special Events - Florida Georgia Game Contingency, \$238,705.27 of funds are appropriated from Council District 1 Autumn Bond funds, and \$95,000.00 are a transfer from Terry Parker Pool funds to provide funding for a new artificial turf field at Blue Cypress Park, located in Council District 1.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funds for a new artificial turf field at Bly Cypress Park, located in Council District 1. The Project is more fully described in Exhibit 2 attached hereto and incorporated herein by this reference. The current grass fields cannot be adequately maintained by the City due to the extremely high level of use by the public. Installation of a synthetic turf field is economical in this situation because use of the synthetic turf field will allow for alternating use and allow time for the grass fields to recover in between uses.

Section 3. Agreement approved and execution authorized. There is hereby approved, and the Mayor, or his designee, and Corporation Secretary are hereby authorized to execute and deliver, a purchase and installation agreement between the City of Jacksonville and Southern Recreation, Inc., in a form prepared and approved by the

Office of General Counsel (the "Agreement") consistent with this legislation.

Section 4. Invoking the exception to Section 126.107(g), Ordinance Code. The City is hereby authorized to procure the purchase and installation of materials from Southern Recreation, Inc. to provide for the installation of a synthetic soccer turf field at Blue Cypress Park, consistent with the scope and estimate attached hereto as Exhibit 2 and incorporated by reference herein. Pursuant to Section 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126 (Procurement Code), Ordinance Code, such procurement is exempted from competitive solicitation because the supplies or services are to be provided by those specifically prescribed within authorizing legislation that appropriates the same. With the exception of the foregoing, all other provisions of Chapter 126, Ordinance Code, shall remain in full force and effect.

Section 5. Reverter. Any remaining funds after the completion of the Project shall be returned to the source of origin.

Section 6. Oversight. The Mayor is requested to appoint the Parks, Recreation and Community Services Department to oversee the project as described in Section 2 above and to ensure compliance with all other appropriate laws.

Section 7. CIP Amendment and Findings. Ordinance 2020-505-E, being the 2021-2025 Five-Year Capital Improvement Program for the City and certain of its independent agencies, is hereby amended to authorize the project entitled "Blue Cypress Park Soccer Field." This project is more fully described in the Project Information Sheet, attached hereto as Exhibit 3 and incorporated herein by this reference. This ordinance shall constitute an amendment to Ordinance 2020-505-E. In all other respects, the Five-Year Capital Improvement Program approved by Ordinance 2020-505-E shall continue in full force and effect. The Council finds that the deferral of this amendment

until the next annual budget and CIP review will be detrimental to the best interest of the community because the fields at Blue Cypress Park have been heavily utilized and it is difficult to adequately maintain grass fields when they are constantly being used. By installation of an alternative field type, the proposed synthetic turf field, it will allow for the City to maintain and preserve the existing grass fields and provide an economical long-term solution. Pursuant to Section 122.605(c), Ordinance Code, a vote on this ordinance shall require the affirmative vote of two-thirds of the Council Members present at the meeting because of the CIP amendment set forth in this section.

Section 8. Requesting One Cycle Emergency Passage Pursuant to Council Rule 4.901 Emergency. One cycle emergency passage of this legislation is requested. The nature of the emergency is that a portion of the funding needed for the project is funding that is currently being considered for other pending projects and so consideration of this legislation concurrent with the other legislation is requested.

Section 9. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
