4 **RESOLUTION 2023-517**

5 A RESOLUTION CONFIRMING THE APPOINTMENT OF
6 LANTIE ELISABETH JORANDBY, AS A MEMBER OF THE
7 OPIOID AND SUBSTANCE USE DISORDER GRANTS
8 COMMITTEE, AS A HEALTHCARE PROFESSIONAL
9 REPRESENTATIVE, PURSUANT TO SECTION 84.202
10 (COMPOSITION; CITY COUNCIL LIAISON; TERMS;
11 REMOVAL), PART 2 (OPIOID AND SUBSTANCE USE
12 DISORDER GRANTS COMMITTEE), CHAPTER 84 (OPIOID
13 SETTLEMENT PROCEEDS GRANTS), *ORDINANCE CODE*, FOR
14 A FIRST FULL TERM ENDING ON JUNE 30, 2025;
15 ESTABLISHING SUBSTANTIAL BUSINESS INTEREST IN
16 DUVAL COUNTY, PURSUANT TO SECTION 50.102(B)
17 (RESIDENCY REQUIREMENT) (MEMBERS OF BOARDS AND
18 COMMISSIONS), PART 1 (ORGANIZATION) CHAPTER 50
19 (ORGANIZATION OF BOARDS AND COMMISSIONS),
20 *ORDINANCE CODE*; REQUESTING ONE-CYCLE EMERGENCY
21 PASSAGE; PROVIDING AN EFFECTIVE DATE.

23 **WHEREAS**, Ordinance 2023-350-E established the Opioid and
24 Substance Use Disorder Grants Committee (the "Committee") to act as
25 an advisory body for the City of Jacksonville and to review, evaluate
26 and score grant applications to fund projects and programs aimed at
27 combatting the opioid crisis; and

28 **WHEREAS**, Section 84.202, *Ordinance Code*, outlines the
29 composition of the Committee which shall consist of seven voting
30 members, three of whom shall be appointed by the Mayor and confirmed
31 by Council and three of whom shall be appointed by the Council

1 President and confirmed by Council; and

2 **WHEREAS,** the Mayor and Council President shall each appoint
3 one member to the Committee from each of the following categories:

4 (i) Mental Health Professional, (ii) Peer Specialist, and (iii)
5 Healthcare Professional; and

6 **WHEREAS,** the members of the Committee are chosen to provide
7 knowledge of needed services, shall demonstrate an interest in the
8 impact of opioid-related programs in the community, and a willingness
9 to participate fully in the process; now therefore

10 **BE IT RESOLVED** by the Council of the City of Jacksonville:

11 **Section 1. Appointment.** The Council hereby confirms the
12 Mayor's appointment of Lantie Elisabeth Jorandby, a Duval County
13 resident, to the Opioid and Substance Use Disorder Grants Committee,
14 as a Healthcare Professional representative, in accordance with
15 Section 84.202 (Composition; City Council Liaison; Terms; Removal),
16 Part 2 (Opioid and Substance Use Disorder Grants Committee), Chapter
17 84 (Opioid Settlement Proceeds Grants), *Ordinance Code*, for a first
18 full term expiring on June 30, 2025.

19 **Section 2. A Non-Resident of Duval County with substantial**
20 **economic business interests in Duval County.** Section 50.102 (Members
21 of Boards and Commissions), Part 1 (Organization), Chapter 50
22 (Organization of Boards and Commissions); *Ordinance Code*, requires
23 Board and Commission members be either a Duval Country resident or
24 individuals with substantial economic business interests in Duval
25 County. Dr. Jorandby has substantial business interests in Duval
26 County. Since 2019, Dr. Jorandby has been serving as the Chief Medical
27 Officer for Lakeview Health, a dual diagnosis treatment facility
28 located in Jacksonville, Florida.

29 **Section 2. Requesting One-cycle emergency Passage Pursuant**
30 **to Council Rule 4.901 (Declaration of Emergency), Part 9 (Emergency**
31 **Legislation), Chapter 4 (Procedures).** One-cycle emergency passage

1 of this legislation is requested. The nature of the emergency is that
2 applications for the initial Opioid Settlement Proceeds Grants cycle
3 (Fiscal Year 2023-2024) must be submitted by no later than September
4 30, 2023. The City Council would like to seat the Committee members
5 as soon as possible to provide the members and staff time to schedule
6 their initial organizational and training meetings to prepare for the
7 grant cycle.

8 **Section 3. Effective Date.** This resolution shall become
9 effective upon signature by the Mayor or upon becoming effective
10 without the Mayor's signature.
