Florida Department of Health in Duval Update on COVID-19

Dr. Pauline Rolle said that percent positives have trended downward between 5% and 8%. Vaccines will continue to be given at the Regency location and will be closing at the end of this week at the Prime Osborne location. Dr. Rolle said that 47% of people over 65 years old have been vaccinated in Duval County. CM Bowman and CM Newby asked about spouses where one is over 65 and the other is under 65 years old. Dr. Rolle said they are trying to accommodate those situations, but a lot has to with the amount of vaccines that are available. CM Pittman asked if there have been accommodations for those that are disabled and with underlying medical issues that are under 65 years old. Dr. Rolle said there are some vaccines available, but the issue is the amount in the stockpile.

Kirk Wendland, Office of Economic Development, detailed the work that has been directed towards food deserts in the northwest. Mr. Wendland explained that this bill will appropriate funding from the Northwest Jacksonville Economic Development Fund for a Jacksonville Transportation Authority program which will give rides to residents that are in the food desert zone. This continues the pilot program which averaged about 140 rides per month to the 7 grocery stores in the zone. CM Becton emphasized the need for a long term plan and suggested a consistent bus route in the area which connects residents to the grocery stores in the area. CM Freeman suggested the idea of a city owned grocery store. Mr. Wendland said that he doesn't think that would work. Carnell Oliver talked about the need for State appropriations. Stanley Scott said he has a concern about the intellectual capital in the community.
