Purpose. The purpose of the appropriation in Section 2. Section 1 is to establish the fiscal year 2025-2026 operating budget for the Inmate Welfare Trust Fund in accordance with Section 111.300, Ordinance Code, and Section 951.23(9), Florida Statutes. appropriation includes \$1,187,388.26 for admission packs, indigent library supplies, recreational equipment, law tracking/records software costs; \$1,252,497.00 for Specialized Equipment for various capital equipment items at the Community Transition Center, the Montgomery Correctional Facility and the Pre-Trial Detention Facility; and \$174,385.05 in various salary accounts for employees whose duties directly relate to the Trust Fund; \$362.62 in City employees' Worker's Compensation; \$12,500.00 for General Liability Insurance.
