**ORDINANCE 2025-720**

AN ORDINANCE APPROPRIATING \$400,000 FROM THE CIP DEBT SERVICE REPAYMENT - ISA-DEBT MANAGEMENT FUND - INTEREST ACCOUNT TO THE FILM AND TELEVISION OFFICE TRUST - SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORG ACCOUNT, TO FUND THE OFFICE OF ECONOMIC DEVELOPMENT FILM AND TELEVISION INCENTIVE FOR "PROJECT T"; PROVIDING FOR CARRYOVER TO FISCAL YEAR 2025-2026; PROVIDING FOR REVERTER; REQUESTING ONE CYCLE EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

**BE IT ORDAINED** by the Council of the City of Jacksonville:

**Section 1. Appropriation.** For the 2024-2025 fiscal year, within the City's budget, there is hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) Explanation of Appropriation:

The funding above represents an appropriation of \$400,000 from the CIP Debt Service Repayment - ISA-Debt Management Fund - Interest account to the Film and Television Office Trust - Subsidies and Contributions to Private Org account,

1 to fund the Office of Economic Development Film and  
2 Television incentive for "Project T."

3 **Section 2. Purpose.** The purpose of the appropriation in  
4 Section 1 is to set aside funds for a Film and Television incentive  
5 to "Project T" to be negotiated through the Office of Economic  
6 Development.

7 **Section 3. Carryover.** The funds appropriated herein shall  
8 not lapse but shall carryover to Fiscal Year 2025-2026.

9 **Section 4. Reverter.** Any funds from this appropriation not  
10 utilized for incentives for "Project T" shall not be used for any  
11 other purpose and shall revert back to the General Fund.

12 **Section 5. Requesting One Cycle Emergency Passage Pursuant**  
13 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this  
14 legislation is requested. The nature of the emergency is that the  
15 City Council desires to ensure the funds appropriated herein do not  
16 lapse before the end of the fiscal year.

17 **Section 6. Effective Date.** This Ordinance shall become  
18 effective upon signature by the Mayor or upon becoming effective  
19 without the Mayor's signature.
