5 AN ORDINANCE APPROPRIATING \$128,160 FROM THE
6 SPECIAL LAW ENFORCEMENT TRUST FUND (THE "FUND")
7 FOR A DONATION TO I.M. SULZBACHER CENTER FOR THE
8 HOMELESS, INC., IN THE AMOUNT OF \$42,000 IN
9 ACCORDANCE WITH SECTION 932.7055(5), FLORIDA
10 STATUTES, TO SUPPORT DRUG TREATMENT, DRUG ABUSE
11 EDUCATION, DRUG PREVENTION, CRIME PREVENTION,
12 SAFE NEIGHBORHOODS, AND SCHOOL RESOURCE OFFICER
13 PROGRAM(S), TRANSFERRING \$12,500 FROM THE FUND
14 TO THE TEEN DRIVER SPECIAL REVENUE FUND FOR THE
15 TEEN DRIVER CHALLENGE PROGRAM, IN ACCORDANCE
16 WITH SECTION 111.365, *ORDINANCE CODE*,
17 TRANSFERRING \$7,500 FROM THE FUND TO THE POLICE
18 EXPLORERS TRUST FUND FOR THE JACKSONVILLE
19 SHERIFF'S POLICE EXPLORER POST, AND \$66,160 FROM
20 THE FUND TO REIMBURSE THE GENERAL FUND FOR
21 FORFEITURE RELATED EXPENDITURES IN ACCORDANCE
22 WITH SECTION 932.7055(4)(C), FLORIDA STATUTES;
23 PURPOSE OF APPROPRIATION; APPROVING AND
24 AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND THE
25 CORPORATION SECRETARY TO EXECUTE AND DELIVER ON
26 BEHALF OF THE CITY, A MISCELLANEOUS
27 APPROPRIATIONS AGREEMENT BETWEEN THE CITY OF
28 JACKSONVILLE AND I.M. SULZBACHER CENTER FOR THE
29 HOMELESS, INC.; WAIVING SECTION 110.112,
30 (ADVANCE OF CITY FUNDS; PROHIBITION AGAINST),
31 PART 1 (THE CITY TREASURY), CHAPTER 110 (CITY

1 Florida. A Certification from the Jacksonville Sheriff's Office that
2 this appropriation from the Special Law Enforcement Trust Fund
3 complies with Section 932.7055(5), Florida Statutes, is attached
4 hereto as **Exhibit 2** and incorporated herein by this reference.

5 In addition to the above, this appropriation includes a transfer
6 of \$12,500 from the Fund to the Teen Driver Special Revenue Fund for
7 the Teen Driver Challenge Program in accordance with Section 111.365,
8 *Ordinance Code*, a transfer of \$7,500 from the Fund to the Police
9 Explorers Trust Fund for the Jacksonville Sheriff's Office Police
10 Explorer Post, in accordance with Section 111.340, *Ordinance Code*,
11 and \$66,160 from the Fund to reimburse the General Fund for
12 forfeiture-related expenditures in accordance with Section
13 932.7055(4)(c), Florida Statutes.

14 **Section 3. Approval and Authorization.** There is hereby
15 approved, and the Mayor, or his designee, and the Corporation
16 Secretary are hereby authorized to execute and deliver on behalf of
17 the City, the Miscellaneous Appropriations Agreement between the City
18 of Jacksonville and I.M. Sulzbacher Center for the Homeless, Inc.
19 (the "Agreement") in substantially the same form as has been placed
20 **On File** with the Office of Legislative Services.

21 **Section 4. Waiving Section 110.112, Ordinance Code.**
22 Section 110.112 (Advance of City funds; prohibition against), Part 1
23 (The City Treasury), Chapter 110 (City Treasury), *Ordinance Code*, is
24 hereby waived to allow for advance payment as described in the
25 Agreement.

26 **Section 5. Oversight.** The Jacksonville Sheriff's Office
27 shall oversee the Agreement described herein.

28 **Section 6. Effective Date.** This Ordinance shall become
29 effective upon signature by the Mayor or upon becoming effective
30 without the Mayor's signature.
