4 **ORDINANCE 2025-73**

5 AN ORDINANCE AUTHORIZING THE MAYOR, OR HER  
6 DESIGNEE, AND CORPORATION SECRETARY TO EXECUTE  
7 AND DELIVER AN AMENDMENT ONE AND AMENDMENT TWO  
8 TO THE AMENDED AND RESTATED NAMING RIGHTS  
9 AGREEMENT (THE "AGREEMENT") AMONG EVERBANK, NA,  
10 JACKSONVILLE JAGUARS, LLC, AND THE CITY OF  
11 JACKSONVILLE, TO EXTEND THE TERM OF THE  
12 AGREEMENT BY THREE YEARS TO FEBRUARY 28, 2028,  
13 TO EXTEND THE CITY'S WAIVER OF ANY RIGHT TO  
14 RECEIVE ANY PORTION OF THE NAMING SPONSOR FEE  
15 TO FEBRUARY 28, 2028, AND TO AUTHORIZE A NAME  
16 CHANGE OF THE STADIUM FROM TIAA BANK FIELD TO  
17 EVERBANK STADIUM, AND TO AMEND THE FINANCIAL  
18 TERMS BETWEEN THE NAMING SPONSOR AND TEAM, AS  
19 ORIGINALLY AUTHORIZED BY ORDINANCE 2014-561-E;  
20 PROVIDING FOR CITY OVERSIGHT BY THE SPORTS AND  
21 ENTERTAINMENT OFFICE; PROVIDING AN EFFECTIVE  
22 DATE.

24 **WHEREAS,** the City of Jacksonville (the "City") and the  
25 Jacksonville Jaguars, LLC ("JJL"), as successor in interest to the  
26 Jacksonville Jaguars, Ltd., and EverBank, NA, previously entered into  
27 that certain Amended and Restated Naming Rights Agreement as  
28 authorized by 2014-561-E (the "Naming Agreement"), which authorized  
29 an extension to the term thereof; and

30 **WHEREAS,** the City and JJL desire to amend the Naming Agreement  
31 to extend the expiration date of the Naming Agreement for a period

1 of three years, from February 28, 2025 to February 28, 2028, authorize  
2 a name change of the Stadium from TIAA Bank Field to EverBank Stadium,  
3 and certain other terms as set forth and pursuant to the Amendment  
4 One and Amendment Two placed **On File** with Legislative Services  
5 Division; now therefore

6 **BE IT ORDAINED** by the Council of the City of Jacksonville:

7 **Section 1. Amendment One and Amendment Two to Amended and**  
8 **Restated Naming Rights approved and execution authorized.** There are  
9 hereby approved, and the Mayor (or her designee) and Corporation  
10 Secretary are hereby authorized to execute and deliver, that certain  
11 Amendment One and Amendment Two to Amended and Restated Naming Rights  
12 Agreement among EverBank, Jacksonville Jaguars, LLC, and City of  
13 Jacksonville, to extend the term of the Agreement by three years to  
14 February 28, 2028, extend the City's waiver of any rights to receive  
15 a portion of the Naming Sponsor Fee to February 28, 2028 and to  
16 authorize a name change of the Stadium from TIAA Bank Field to  
17 EverBank Stadium, and amend certain other terms as set forth in  
18 Amendment One and Amendment Two to the Amended and Restated Naming  
19 Rights Agreement substantially in the forms placed **On File** with  
20 Legislative Services Division and incorporated herein by this  
21 reference.

22 **Section 2. Oversight Department.** The City of Jacksonville  
23 Sports and Entertainment Office shall oversee the Agreements  
24 described herein.

25 **Section 3. Effective Date.** This ordinance shall become  
26 effective upon signature by the Mayor or upon becoming effective  
27 without the Mayor's signature.
