AN ORDINANCE APPROPRIATING \$10,000 FROM THE SPECIAL COUNCIL CONTINGENCY ACCOUNT TO THE KIDS HOPE ALLIANCE FUND (10901) - ESP - OUT-OF-SCHOOL TIME PROGRAMMING ESSENTIAL SERVICES CATEGORY, TO PROVIDE FUNDING TO JACKSONVILLE ARTS AND MUSIC SCHOOL INC. ("JAMS") FOR THE JAMS "CREATED" PROGRAM (THE "PROGRAM") AS DESCRIBED HEREIN; PROVIDING FOR CARRYOVER TO FISCAL YEAR 2025-2026; AMENDING THE NINTH REVISED SCHEDULE M TO ORDINANCE 2024-511-E; WAIVING CERTAIN REQUIREMENTS OF SECTION 77.111 (CONTRACTS; CONTRACT ADMINISTRATION; CARRYOVER), CHAPTER 77 (KIDS HOPE ALLIANCE), ORDINANCE CODE, TO EXEMPT THE SERVICES TO BE PROVIDED BY JAMS FROM COMPETITIVE PROCUREMENT; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY, AND/OR THE CHIEF EXECUTIVE OFFICER OF THE KIDS HOPE ALLIANCE ("KHA") TO EXECUTE AND DELIVER ON BEHALF OF THE CITY A GRANT AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND JACKSONVILLE ARTS AND MUSIC SCHOOL INC. FOR THE PROGRAM; PROVIDING FOR OVERSIGHT BY KHA; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2024-2025 fiscal year, within the City's budget, there is hereby appropriated the indicated

(c) Explanation of Appropriation:

The funding above is an appropriation of \$10,000 from the Special Council Contingency account to the Kids Hope Alliance Fund (10901) - ESP - Out-of-School-Time - Subsidies and Contributions to Private Org account to provide a grant to Jacksonville Arts and Music School inc. ("JAMS") for the JAMS "creatED" Program (the "Program") as described herein.

Section 2. The purpose of the appropriation in Purpose. Section 1 is to provide funding from the City of Jacksonville to JAMS for the JAMS "creatED" Program as described in Exhibit 2, attached hereto and incorporated herein by this reference. The Program was designed to assist both art educators in helping with skills development as well as youth seeking opportunities to develop their artistic talents and abilities. For art educators, the Program serves as a professional development and community arts engagement program to equip teachers and professional artists with skills and strategies to serve underserved youth and families through the arts by providing workshops to enhance their skills in arts integration, creative instruction and youth engagement. The Program serves its youth participants, specifically children in grades 3 through 12, by providing afterschool and summer programming, including instruction during the school year and a six-week summer program in

music, dance, theater, visual arts, drama and creative writing. The Program also provides a community engagement component through public showcases and student-led collaborative projects. The City funds will be used to cover the costs to host professional development workshops for teachers and professional artists as well as quarterly community events which will be open to the public. These quarterly events will offer an opportunity for youth, educators and artists to showcase their collaborations and to highlight student achievements to the community.

Section 3. Carryover. The funds appropriated herein shall not lapse but shall carryover to fiscal year 2025-2026.

Section 4. Amending the Ninth Revised Schedule M to Ordinance 2024-511-E. The Kids Hope Alliance ("KHA") fiscal year 2024-2025 budget approved by Ordinance 2024-511-E is hereby amended by substituting in place of the Ninth Revised Schedule M, the Tenth Revised Schedule M, attached hereto as Exhibit 3 and incorporated herein by this reference, to reflect the funds appropriated herein.

Section 5. Waiving Certain Requirements of Section 77.111, Ordinance Code. The City hereby waives certain requirements of Section 77.111 (Contracts; contract administration; carryover), Chapter 77 (Kids Hope Alliance), Ordinance Code, with respect to the contract with JAMS and authorized by this Ordinance. Specifically, subsection 77.111(a) requires Provider Contracts for children's services provided by third parties to be competitively procured by KHA via an evaluated bid process. This waiver is needed in order to allow KHA to directly contract with Jacksonville Arts and Music School Inc. for the JAMS "creatED" Program described in Exhibit 2.

Section 6. Approval and Authorization to Execute. There is hereby approved, and the Mayor, or her designee, and the Corporation Secretary, and/or the Chief Executive Officer of KHA, are hereby authorized to execute and deliver on behalf of the City or KHA, an

agreement with JAMS in an amount not-to-exceed \$10,000. The agreement shall be subject to and administered in accordance with Chapter 77, Ordinance Code, and the terms, scope and budget more particularly described in Exhibit 2, for a term commencing on September 1, 2025 through September 30, 2026, and all other contracts and documents, including extensions, renewals and amendments to the agreement, and to otherwise take all action necessary to effectuate the intent of this Ordinance, subject to appropriate legal review and approval by the General Counsel, or his or her designee, and the City's Risk Management Division for appropriate insurance and indemnification requirements in accordance with Section 128.601, Ordinance Code.

Section 7. Oversight Department. The Kids Hope Alliance shall oversee the project described herein.

Section 8. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
