7 AN ORDINANCE AMENDING SECTION 129.102 (SALARY  
8 OF MEMBERS OF COUNCIL; SALARY OF COUNCIL  
9 PRESIDENT), CHAPTER 129 (COMPENSATION OF CITY  
10 OFFICIALS AND EMPLOYEES), *ORDINANCE CODE*, TO  
11 REQUIRE EACH COUNCIL MEMBER TO SUBMIT IN  
12 WRITING A NOTIFICATION WITH THE COUNCIL  
13 DIRECTOR/SECRETARY AS TO THEIR ELECTION FOR  
14 SALARY PLACEMENT FOR THE UPCOMING FISCAL YEAR  
15 PRIOR TO OCTOBER 1 OF THE AFFECTED FISCAL YEAR  
16 AND REQUIRING PUBLICATION OF SAME; PROVIDING  
17 AN EFFECTIVE DATE.

19 **WHEREAS**, Section 129.102, *Ordinance Code*, provides the  
20 mechanism for calculating the annual salary of the Council Members;  
21 and

22 **WHEREAS**, the Council desires to amend the provisions of  
23 Section 129.102, *Ordinance Code*, so that any increase in the  
24 members of Council's annual salary from year to year will require  
25 separate legislation apart from the annual budget legislation; and

26 **WHEREAS**, this legislation shall be known as the "No Obligatory  
27 Pay Enlargements" ("NOPE") bill; now therefore,

28 **BE IT ORDAINED** by the Council of the City of Jacksonville:

29 **Section 1. Amending Section 129.102 (Salary of Members of**  
30 **Council; salary of Council President), Chapter 129 (Compensation of**  
31 **City Officials and Employees), *Ordinance Code*. Section 129.102**

1 (Salary of Members of Council; salary of Council President),  
2 Chapter 129 (Compensation of City Officials and Employees),  
3 *Ordinance Code*, is hereby amended to read as follows:

4 **CHAPTER 129. COMPENSATION OF CITY OFFICIALS AND EMPLOYEES.**

6 **Sec. 129.102. Salary of Members of Council; salary of Council**  
7 **President.**

8 (a) Each member of the Council, other than the Council President,  
9 shall receive an annual salary equal to one-half of the salary  
10 allowed for a member of the Board of County Commissioners in a  
11 county with a population equal to that of Duval County, in  
12 accordance with the provisions of F.S. §§ 145.031(1) and  
13 145.19; provided however, each Council Member shall submit in  
14 writing a notification with the Council Director/Secretary as  
15 to their election for salary placement for the upcoming fiscal  
16 year prior to October 1 of the affected fiscal year. The  
17 notifications shall be published each year on the City Council  
18 website.

19 (b) The Council President shall receive a salary equal to the  
20 salary allowed for a member of the Council in subsection (a) of  
21 this Section plus an additional amount equal to one-third of  
22 that salary.

23 **Section 2. Effective Date.** This ordinance shall become  
24 effective upon signature by the Mayor or upon becoming effective  
25 without the Mayor's signature.
