4 **ORDINANCE 2021-714**

5 AN ORDINANCE AUTHORIZING THE GRANTING OF A NON-
6 RESIDENTIAL SOLID WASTE COLLECTION AND
7 TRANSPORTATION FRANCHISE TO MACO PARTNERS INC
8 D/B/A FROG HAULING & DEMOLITION PURSUANT TO
9 CHAPTER 380 (SOLID WASTE MANAGEMENT), PART 6
10 (NONRESIDENTIAL SOLID WASTE COLLECTION AND
11 TRANSPORTATION FRANCHISES), *ORDINANCE CODE*;
12 PROVIDING FOR OVERSIGHT BY THE DEPARTMENT OF
13 PUBLIC WORKS, SOLID WASTE DIVISION; PROVIDING AN
14 EFFECTIVE DATE.

16 **WHEREAS**, Maco Partners Inc. d/b/a Frog Hauling & Demolition
17 ("Maco Partners") has submitted an application for a non-residential
18 solid waste collection and transportation franchise pursuant to the
19 provisions of Chapter 380, Part 6, *Ordinance Code*; and

20 **WHEREAS**, the application was reviewed by the Solid Waste
21 Division of the Department of Public Works; and

22 **WHEREAS**, the Department of Public Works recommends granting a
23 franchise for non-residential solid waste collection and
24 transportation to Maco Partners; and

25 **WHEREAS**, granting a non-residential solid waste collection and
26 transportation franchise to Maco Partners will further the purpose
27 for which the franchise program was adopted, including, but not
28 limited to, safeguarding public health, safety and welfare in the
29 collection and transportation of solid waste through Jacksonville;
30 now therefore

31 **BE IT ORDAINED** by the Council of the City of Jacksonville:

1 **Section 1. Franchise Agreement authorized.** In accordance
2 with the provisions of Chapter 380 (Solid Waste Management), Part 6
3 (Nonresidential Solid Waste Collection and Transportation
4 Franchises), *Ordinance Code*, the Director of the Public Works
5 Department is hereby authorized to issue a franchise agreement to
6 Maco Partners Inc. d/b/a Frog Hauling & Demolition for collection and
7 transportation of non-residential solid waste in the City of
8 Jacksonville. Maco Partners has paid the application fee of
9 \$1,500.00. A copy of the Non-Residential Solid Waste Collection and
10 Transportation Franchise Agreement is attached hereto as **Exhibit 1**
11 and incorporated herein by this reference. A copy of the letter from
12 the Department of Public Works forwarding Maco Partner's application
13 to the Council for action is attached hereto as **Exhibit 2** and
14 incorporated herein by this reference.

15 **Section 2. Oversight.** The Solid Waste Division of the
16 Department of Public Works shall oversee the franchise described
17 herein.

18 **Section 3. Effective Date.** This Ordinance shall become
19 effective upon signature by the Mayor or upon becoming effective
20 without the Mayor's signature.
