KHA Lease with Lutheran Services Florida

Please provide the Kids Hope Alliance (KHA) with the authority to request the legislation necessary for the City Council to authorize KHA to amend our lease with Lutheran Services Florida (LFS). The lease amendment would become effective on February 1<sup>st</sup>, 2021, upon City Council approval, and would follow the same.

The lease amount would be reduced to \$0 annually and would add approximately 2,000 square feet within the Kids Hope Alliance building at 1095 A. Phillip Randolph Blvd., Jacksonville, FL 32206. By offering this space at no cost to LFS, it allows them to allocate more program funds to serve Head Start children within the community. The extra space will provide their Head Start teachers space to hold team meetings and work on lesson planning, which they are currently doing within one of the classrooms at the Brewers Center (therefore, that classroom could be opened up to children).
