5 AN ORDINANCE APPROPRIATING \$366,500.00 FROM
6 THE SPECIAL LAW ENFORCEMENT TRUST FUND TO: 1)
7 PROVIDE FUNDING IN THE AMOUNT OF \$351,000.00
8 TO ESTABLISH THE FISCAL YEAR 2019-2020 BUDGET
9 FOR THE SPECIAL LAW ENFORCEMENT TRUST FUND
10 (SUBFUND 64A) PURSUANT TO SECTION 111.310,
11 *ORDINANCE CODE*, REIMBURSE THE GENERAL FUND FOR
12 FORFEITURE-RELATED EXPENDITURES PER SECTION
13 932.7055(4)(C), FLORIDA STATUTES, FUND THE
14 HOMEWARD BOUND PROGRAM, FUND THE EXPANSION OF
15 THE BERM AT THE FIRING RANGE, AND FUND
16 LEASEHOLD IMPROVEMENTS FOR THE NEW ZONE 6
17 SUBSTATION; 2) AUTHORIZE THE TRANSFER OF
18 \$3,000.00 TO THE TEEN DRIVER SPECIAL REVENUE
19 FUND (SUBFUND 64A) PURSUANT TO SECTION
20 111.365, *ORDINANCE CODE*; AND, 3) AUTHORIZE THE
21 TRANSFER OF \$12,500.00 TO THE POLICE EXPLORER
22 TRUST FUND (SUBFUND 64C) PURSUANT TO SECTION
23 111.340, *ORDINANCE CODE*, AS INITIATED BY B.T.
24 20-009; PROVIDING AN EFFECTIVE DATE.

26 **BE IT ORDAINED** by the Council of the City of Jacksonville:

27 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
28 within the City's budget, there are hereby appropriated the
29 indicated sum(s) from the account(s) listed in subsection (a) to
30 the account(s) listed in subsection (b):

6 (c) Explanation of Appropriation

7 The funding above in the amount of \$366,500.00 (an
8 appropriation of \$296,778.23 from the Special Law
9 Enforcement Trust Fund (the "Fund") and a deappropriation
10 of \$69,721.77 from the Fund) is provided to establish the
11 fiscal year 2019-2020 budget for the Fund, and to
12 authorize intrafund transfers to the Teen Driver Special
13 Revenue Fund and the Police Explorer Fund.

14 **Section 2. Purpose.** The purposes of the appropriation in
15 Section 1 are to: i) provide funding in the amount of \$351,000.00
16 to establish the fiscal year 2019-2020 budget for the Special Law
17 Enforcement Trust Fund (subfund 64A) pursuant to Section 111.310,
18 *Ordinance Code*, specifically \$36,000.00 to reimburse the General
19 Fund for forfeiture-related expenditures per Section
20 932.7055(4)(c), Florida Statute, \$10,000.00 to fund the Homeward
21 Bound Program, \$80,000.00 to fund the expansion of the berm at the
22 firing range, and \$225,000.00 to fund leasehold improvements for
23 the new Zone 6 Substation; ii) authorize the transfer of \$3,000.00
24 to the Teen Driver Special Revenue Fund (subfund 64A) pursuant to
25 Section 111.365, *Ordinance Code*; and, iii) authorize the transfer
26 of \$12,500.00 to the Police Explorer Trust Fund (subfund 64C)
27 pursuant to Section 111.340, *Ordinance Code*. A Certification that
28 the request from the Special Law Enforcement Trust Fund complies
29 with §932.7055, Florida Statutes, is attached hereto as **Exhibit 2**
30 and incorporated herein by this reference.

31 **Section 3. Effective Date.** This ordinance shall become

1 effective upon signature by the Mayor or upon becoming effective
2 without the Mayor's signature.
