5 **ORDINANCE 2023-501**

6 AN ORDINANCE LEVYING ANNUAL TAXES FOR THE 2023
7 CALENDAR YEAR ON REAL AND PERSONAL PROPERTY
8 LOCATED IN THE GENERAL SERVICES DISTRICT OF THE
9 CITY OF JACKSONVILLE, NOT INCLUDING THE SECOND,
10 THIRD, FOURTH AND FIFTH URBAN SERVICES DISTRICTS
11 (THE CITIES OF ATLANTIC BEACH, NEPTUNE BEACH,
12 JACKSONVILLE BEACH AND THE TOWN OF BALDWIN);
13 STATING THE PERCENTAGE CHANGE FROM THE 2023
14 ROLLED-BACK RATE; AUTHORIZING ASSESSMENT AND
15 COLLECTION; PROVIDING FOR THE USE OF THE
16 REVENUES GENERATED; PROVIDING AN EFFECTIVE DATE.

18 **BE IT ORDAINED** by the Council of the City of Jacksonville:

19 **Section 1. Ad Valorem Tax Levy - General Services District,**
20 **Excepting Urban Services Districts 2 through 5 (The Beaches and the**
21 **Town of Baldwin).** In accordance with Chapter 200, *Florida Statutes*,
22 for the year 2023, there are hereby levied upon all taxable property
23 located within the General Services District of the city, excepting
24 the Second, Third, Fourth and Fifth Urban Services Districts, for
25 county, district and municipal purposes, ad valorem taxes expressed
26 in terms of mills on each dollar of assessed taxable valuation in the
27 amount of 11.3169 mills, or \$11.3169 per \$1,000 assessed taxable
28 value.

29 **Section 2. Percentage Change From the Rolled-Back Rate.**

30 The 2023 operating millage rate levied herein by the Consolidated
31 City of Jacksonville upon property within the General Services

1 District of the city, excepting the Second, Third, Fourth and Fifth
2 Urban Services Districts, represents a 9.39% increase from the 2023
3 rolled-back rate set forth in Resolution 2023-500-A.

4 **Section 3. Assessment and Collection.** The Property
5 Appraiser of the county is authorized and directed to assess, and the
6 Tax Collector of the county is authorized and directed to collect,
7 pursuant to law, the ad valorem taxes levied in this Ordinance.

8 **Section 4. Use of Revenues.** The revenues raised by the ad
9 valorem taxes levied in this Ordinance shall be utilized in the manner
10 and for the purposes specified in the 2023-2024 budget and
11 appropriations ordinance.

12 **Section 5. Effective Date.** This Ordinance shall become
13 effective upon signature by the Council President.
