ORDINANCE 2024-835

AN ORDINANCE ADOPTING A MODIFICATION TO THE CITY OF JACKSONVILLE 2045 COMPREHENSIVE PLAN FOR THE PURPOSE OF AMENDING THE CAPITAL IMPROVEMENT ELEMENT SCHEDULE OF PROJECTS TO INCLUDE THE 301 VILLAGES WATER, WASTEWATER AND REUSE WATER FACILITIES AND UPDATING THE 2045 MOBILITY SYSTEM SCHEDULE OF PROJECTS WITHIN THE CAPITAL IMPROVEMENTS ELEMENT TO INCLUDE BRADDOCK ROAD FROM LEM TURNER ROAD TO DUNN AVENUE AND ACREE ROAD EXTENSION FROM NEW KINGS ROAD TO OLD KINGS ROAD AS MOBILITY SYSTEM PROJECTS IN THE CORRIDOR MODE TO MOBILITY ZONE 4; PROVIDING AN EFFECTIVE DATE.

WHEREAS, a modification to the 2045 Comprehensive Plan Capital Improvement Element Schedule of projects and 2045 Mobility System Schedule of Projects, contained in the Capital Improvements Element of the City of Jacksonville 2045 Comprehensive Plan, has been initiated by the Planning and Development Department, which modifications are more particularly set forth in Exhibit 1 and Exhibit 2, attached hereto; and

WHEREAS, on September 24, 2024, the City Council approved Ordinance 2024-505-E, adopting the Fiscal Years 2025-2029 Capital Improvements Plan (the "CIP"), and the Capital Improvements Element Schedule of Projects is a subset of the City's approved CIP; and

WHEREAS, projects within the Capital Improvements Element Schedule may be funded by local, regional, state or federal

governments, or may be privately funded, and therefore, the Capital Improvements Element Schedule includes projects from the North Florida Transportation Planning Organization's Transportation Improvement Plan and Long Range Transportation Plan, as well as the City of Jacksonville's Mobility System Projects; and

WHEREAS, pursuant to Section 163.3177(3)(b), Florida Statutes, the City of Jacksonville may modify the 2045 Comprehensive Plan to update the Five-Year Capital Improvements Element Schedule of Projects by ordinance, and such modification is not deemed an amendment to the 2045 Comprehensive Plan; now, therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Modification to the Capital Improvements Element of the City of Jacksonville 2045 Comprehensive Plan. The Capital Improvements Element of the City of Jacksonville 2045 Comprehensive Plan is hereby modified to include the 301 Villages Water, Wastewater and Reuse Water Facilities and update the 2045 Mobility System Schedule of Projects within the Capital Improvements Element to include Braddock Road from Lem Turner Road to Dunn Avenue and Acree Road Extension from New Kings Road to Old Kings Road as mobility system projects in the corridor mode to Mobility Zone 4. The Planning and Development Department shall place the revised Capital Improvements Element Schedule in the file with the City Council Legislative Services Division, and upon confirmation of Americans with Disabilities Act (ADA) compliance, shall publish the final Capital Improvements Element Schedule on the City's website as part of the Capital Improvements Element of the 2045 Comprehensive Plan.

Section 2. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
