PROGRAM OVERVIEW:

The University of North Florida (UNF) seeks funding from the City of Jacksonville to establish and support its Esports Program. This initiative aims to enhance student engagement, provide workforce development opportunities, and position Jacksonville as a regional leader in the rapidly growing Esports industry. By investing in the Program, UNF will provide students with opportunities for competition, career readiness, and community engagement. This will be a talent development pipeline and engine that will prepare students for high-demand careers in Jacksonville's growing digital economy.

PROGRAM SCOPE OF WORK AND DELIVERABLES:

- Partnerships with local high schools to introduce students to Esports and technology career pathways, including:
 - Annual Esports tournaments open to Jacksonville-area high schools.
 - Mentorship and skills training for high school students interested in pursuing collegiate Esports.
 - Workshops on career pathways in gaming, game development, broadcasting, and Esports management.
 - Collaboration with high school educators to integrate Esports-related curricula into STEM and business programs.
- Hosting of local and regional Esports events to drive economic and educational benefits for Jacksonville.
- Development of a dedicated Esports arena equipped with high-performance gaming systems, broadcasting equipment, and spectator seating.
- Establishment of a competitive collegiate Esports team representing UNF in regional and national tournaments.
- Integration of Esports-related coursework in collaboration with UNF's School of Computing and business programs.

PROGRAM COSTS/PAYMENT TERMS:

Payment shall be made on a cost reimbursement basis upon delivery of the required reporting outlined below.

PROGRAM IMPACT & REPORTING

Goals & Objectives:

• At UNF, Esports will serve as a retention tool, particularly for students in computing, engineering, and digital media fields, where persistence can be a challenge.

- Partner with local high schools and the Jacksonville community to introduce students to Esports and technology career opportunities through mentorship, tournaments, and educational workshops.
- Host local and regional Esports events to drive economic and educational benefits for Jacksonville.
- Strengthen the pipeline between Jacksonville-area high school students and UNF's Esports and technology programs.
- Establish a premier Esports facility on campus by January 2026.
- Recruit and train a competitive collegiate Esports team.

Required Reporting:

- Quarterly progress reports detailing infrastructure development, team recruitment, and Program execution.
- Financial reports outlining expenditure of grant funds, and additional support as requested by the City.
- Impact assessment reports measuring student participation, career outcomes, and community engagement, including high school outreach metrics.
- Documentation of partnerships and participation levels in high school Esports and career pathway programs.

ADDITIONAL GRANT REQUIREMENTS AND CONDITIONS:

Recipient's expenditure of City funds for the Program and the provision of services shall be subject to Chapter 118, Parts 1-5 of the *Jacksonville Ordinance Code*, and the terms and conditions of any contract entered into between the City and Recipient. Recipient shall use the City funds for the Program in accordance with the City Council approved Term Sheet and Program budget. The City's Grant Administrator may amend this Term Sheet or the approved Program budget consistent with the Program's needs, provided that any substantial change to this Term Sheet or a budget change not within 10% of the attached Program budget line-items will require City Council approval.
