5 AN ORDINANCE APPROPRIATING \$13,926.00 IN
6 DEPARTMENT OF HOMELAND SECURITY/FEDERAL
7 EMERGENCY MANAGEMENT AGENCY EMERGENCY
8 MANAGEMENT PERFORMANCE PASS-THROUGH GRANT
9 FUNDING DISTRIBUTED BY THE FLORIDA DEPARTMENT OF
10 EMERGENCY MANAGEMENT AND FUNDED THROUGH THE
11 AMERICAN RESCUE PLAN ACT OF 2021, TO BE USED IN
12 PREPARING FOR, RESPONDING TO, RECOVERING FROM,
13 AND MITIGATING AGAINST THE IMPACTS OF NATURAL
14 AND MAN-MADE EMERGENCIES, AS INITIATED BY B.T.
15 21-122; PROVIDING FOR OVERSIGHT BY THE
16 JACKSONVILLE FIRE AND RESCUE DEPARTMENT,
17 EMERGENCY PREPAREDNESS DIVISION; PROVIDING AN
18 EFFECTIVE DATE.

20 **BE IT ORDAINED** by the Council of the City of Jacksonville:

21 **Section 1. Appropriation.** For the 2021-2022 fiscal year,
22 within the City's budget, there are hereby appropriated the indicated
23 sum(s) from the account(s) listed in subsection (a) to the account(s)
24 listed in subsection (b):

31 (c) Explanation of Appropriation:

1 The funding above represents an appropriation of \$13,926.00
2 in Emergency Management Performance pass-through grant
3 funding from the Department of Homeland Security/Federal
4 Emergency Management Agency distributed by the Florida
5 Department of Emergency Management and funded through the
6 American Rescue Plan Act of 2021. These funds will be used
7 to assist the City of Jacksonville in preparing for,
8 responding to, recovering from, and mitigating the impacts
9 of natural and man-made emergencies as more particularly
10 described herein. The grant period commences July 1, 2021
11 through June 30, 2022. No City match is required.

12 **Section 2. Purpose.** The purpose of the appropriation in
13 Section 1 is to fund the purchase of five (5) satellite phone
14 (portable) kits with Florida SatNet Service to support the
15 Jacksonville Fire and Rescue Department Emergency Preparedness
16 Division's interoperable communications capabilities. In addition,
17 grant funds will be used to procure twenty (20) shelter signs for
18 Duval County's Emergency Operations Center. A copy of the Federally-
19 Funded Subaward Grant Agreement (Agreement Number: G0335) providing
20 the terms and conditions relative to receipt and expenditure of the
21 grant funds has been placed **On File** with the Office of Legislative
22 Services.

23 **Section 3. Oversight.** The Jacksonville Fire and Rescue
24 Department, Emergency Preparedness Division shall oversee
25 administration of the grant described herein.

26 **Section 4. Effective Date.** This Ordinance shall become
27 effective upon signature by the Mayor or upon becoming effective
28 without the Mayor's signature.
