Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funds to procure the services of Fernandina Mulch & Stone, LLC d/b/a Liberty Landscape Supply for the design and installation of landscaping and irrigation in the roundabout located at the intersection of Spring Park Road and Spring Glen Road in Council District 5. The project is estimated to cost a total of \$45,750 of which \$25,750 will be paid from the funds appropriated herein with the remaining \$20,000 to be paid from funds appropriated by Ordinance 2024-879-E.

Section 3. Approval and Authorization to Execute. The Mayor, or her designee, and the Corporation Secretary are hereby authorized to negotiate and execute an agreement, including amendments thereto, with Fernandina Mulch & Stone, LLC d/b/a Liberty Landscape Supply, in a not-to-exceed amount of \$45,750, for the design and installation of landscaping and irrigation in the roundabout located at the intersection of Spring Park Road and Spring Glen Road in Council District 5 as described in the proposal attached hereto as Exhibit 1 and incorporated herein by this reference.

Section 4. Invoking the Exemption in Section 126.108(g), Ordinance Code. The City is hereby authorized to enter into an agreement with Fernandina Mulch & Stone, LLC d/b/a Liberty Landscape Supply for the design and installation of landscaping and irrigation in the roundabout located at the intersection of Spring Park Road and Spring Glen Road as more specifically described herein.
