6 AN ORDINANCE APPROPRIATING \$50,000.00 IN STATE
7 GRANT FUNDING FROM THE STATE OF FLORIDA,
8 DEPARTMENT OF STATE, DIVISION OF HISTORICAL
9 RESOURCES TO FUND THE MAYPORT VILLAGE ORAL
10 HISTORY AND WAYFINDING TOUR, AS INITIATED BY
11 B.T. 26-020; PURPOSE OF APPROPRIATION; APPROVING
12 AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND
13 THE CORPORATION SECRETARY TO EXECUTE AND DELIVER
14 A GRANT AGREEMENT WITH THE STATE OF FLORIDA,
15 DEPARTMENT OF STATE, FOR THE PURPOSE OF
16 PROVIDING THE GRANT FUNDS TO THE CITY; PROVIDING
17 FOR OVERSIGHT BY THE PLANNING DEPARTMENT;
18 PROVIDING AN EFFECTIVE DATE.

20 **BE IT ORDAINED** by the Council of the City of Jacksonville:

21 **Section 1. Appropriation.** For the 2025-2026 fiscal year,
22 within the City's budget, there is hereby appropriated the indicated
23 sum(s) from the account(s) listed in subsection (a) to the account(s)
24 listed in subsection (b):

31 (c) Explanation of Appropriation:

1 The funding above represents an appropriation of state
2 grants funds held in the Miscellaneous Grant Projects fund
3 to conduct an oral history and wayfinding tour for the
4 historic Mayport Village community.

5 **Section 2. Purpose.** The purpose of the appropriation in
6 Section 1 is to provide grant funding of \$50,000 to conduct an oral
7 history and wayfinding tour for the historic Mayport Village
8 community. The scope of work includes procuring professional historic
9 preservation services, conducting archival research, conducting a
10 minimum of five oral history interviews, installing eight
11 interpretive signs, and developing a wayfinding tour.

12 **Section 3. Approval of and authorization to enter Grant**
13 **Agreement.** There is hereby approved, and the Mayor, or her designee,
14 and the Corporation Secretary are hereby authorized to execute and
15 deliver, the Grant Agreement between the City of Jacksonville and the
16 State of Florida, Department of State, in substantially the same form
17 as attached as **Exhibit 2** and incorporated herein by reference for the
18 purposes of providing funds for the grant to the City and enabling
19 the City to fund an oral history and wayfinding tour for the historic
20 Mayport Village community.

21 **Section 4. Oversight.** The City of Jacksonville Planning
22 Department will provide oversight.

23 **Section 5. Effective Date.** This Ordinance shall become
24 effective upon signature by the Mayor or upon becoming effective
25 without the Mayor's signature.
