## ORDINANCE 2019-737

AN ORDINANCE CONCERNING THE FISCAL YEAR 2017-2018 CITY OF JACKSONVILLE BUDGET; AMENDING ORDINANCE 2017-504-E (THE CITY OF JACKSONVILLE "BUDGET ORDINANCE") TO REVISE THE GENERAL CONDITIONS TERMS AND FOR Α REDEVELOPMENT AGREEMENT ("AGREEMENT") BETWEEN THE CITY AND EDWARD WATERS COLLEGE, INC. ("EWC") TO: AUTHORIZE DISBURSEMENTS FROM THE CITY TO EWC ON A WORK PERFORMED AND INVOICED BASIS, RATHER THAN ON A REIMBURSEMENT BASIS; AND (2) REVISE EXHIBIT 6 ATTACHED TO THE BUDGET ORDINANCE; ATTACHING AND INCORPORATING THE REVISED EXHIBIT 6 TO THE BUDGET ORDINANCE; AUTHORIZING THE MAYOR, OR HIS DESIGNEE AND CORPORATION SECRETARY TO EXECUTE AND DELIVER AN AMENDMENT 2 TO THE AGREEMENT TO PROVIDE FOR DISBURSEMENT OF CITY FUNDS ON A WORK PERFORMED AND INVOICED BASIS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Ordinance 2017-504-E, which included the 2017-2018 Fiscal Year budget for the City of Jacksonville (the "Budget Ordinance") was enacted by Council on September 26, 2017, and became effective October 1, 2017; and

WHEREAS, Exhibit 6 attached to the Budget Ordinance set forth the general terms and conditions to be included in an agreement (the "Agreement") to be entered into between the City and Edward

Waters College, Inc. ("EWC"), which in part authorized funding from the City to EWC for capital improvements to be made by EWC on its campus on a reimbursement basis; and

WHEREAS, EWC has requested to authorize disbursement of City funds under the Agreement on a work performed and invoiced basis, rather than on a reimbursement basis, and the City has agreed to the same subject to City Council approval; and

WHEREAS, it is therefore necessary to amend Section 11.18 of the City's 2017-2018 Budget Ordinance to reflect the foregoing; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Amending Section 11.18 (Agreement between the City of Jacksonville and Edward Waters College, Inc. for use of the Community Field and Student Housing and Campus Identification Monument), of Ordinance 2017-504-E, to Revise the Exhibit 6 for the 2017-2018 Budget. Ordinance 2017-504-E, Section 11.18 (Agreement between the City of Jacksonville and Edward Waters College, Inc. for use of the Community Field and Student Housing and Campus Identification Monument), is hereby amended, in part, to revise the Exhibit 6 attached to the Budget Ordinance. The Revised Exhibit 6 is attached hereto as Exhibit 1, and is by this reference, made a part of Ordinance 2017-504-E and replaces Exhibit 6 that is currently attached to the Budget Ordinance. The Revised Exhibit 6 authorizes disbursement of City funds to EWC on a work performed and invoiced basis, rather than on a reimbursement basis.

Amendment Two to Redevelopment Agreement. There is hereby approved, and the Mayor or his designee and Corporation Secretary are authorized to enter into an Amendment Two to Redevelopment Agreement ("Amendment") between the City and EWC, substantially in the form placed On File with the Legislative Services Division.
