13 **BE IT ORDAINED** by the Council of the City of Jacksonville:

14 **Section 1. Amending Section 122.202(d) (Parking rates at**
15 **municipal parking lots), *Ordinance Code*.** Section 122.202(d) (Parking
16 rates at municipal parking lots), Part 2 (Municipal Parking Lots),
17 Chapter 122 (Public Property), *Ordinance Code*, is hereby amended to
18 read as follows:

23 **Sec. 122.202. - Parking rates at municipal parking lots.**

25 (d) Effective October 1, 2014, all City employees (which term
26 shall include all City of Jacksonville employees and
27 employees of the Duval County Supervisor of Elections, Duval
28 County Property Appraiser, Duval County Tax Collector, ~~and~~
29 Duval County Clerk of Court and ~~to~~ employees of the Office
30 of the Public Defender of the Fourth Judicial Circuit), who
31 are monthly parkers at municipal owned parking facilities

1 operated by the Office of Public Parking, shall be entitled
2 to a reduced monthly parking rate, which shall be 50 percent
3 of the established, monthly parking rate for the given
4 facility through September 30, ~~2024~~²⁰²³. The Downtown
5 Investment Authority shall file the employee rate schedule
6 and any subsequent change to the employee rate schedule with
7 the Council Secretary, and such rates shall become effective
8 upon such filing unless and until the Council enacts an
9 ordinance to the contrary.

10 **Section 2. Effective Date.** This Ordinance shall become
11 effective upon signature by the Mayor or upon becoming effective
12 without the Mayor's signature.
