ΑN ORDINANCE APPROPRIATING \$3,887,768.41, INCLUDING CURRENT YEAR SAVINGS OF \$2,617,435.34 FROM THE MAYOR'S CURE VIOLENCE PROGRAM (THE "PROGRAM") AND \$1,270,333.07 FROM GENERAL FUND OPERATING FUND BALANCE RELATED TO THE CLOSEOUT PRIOR YEAR FUNDING FOR THE PROGRAM, PROVIDE \$2,887,768.41 TO SPECIAL COUNCIL CONTINGENCY ACCOUNT TO BE USED FOR CITY COUNCIL STRATEGIC INITIATIVES IN FISCAL YEAR 2024-2025 \$1,000,000.00 TO A COUNCIL PRESIDENT CONTINGENCY ACCOUNT; PROVIDING FOR CARRYOVER TO FISCAL YEAR 2024-2025; REQUESTING ONE CYCLE EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2023-2024 fiscal year, within the City's budget, there is hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

- - The funding above is an appropriation of \$3,887,768.41,

including current year savings of \$2,617,435.34 from the Mayor's Cure Violence Program (the "Program") and \$1,270,333.07 from General Fund Operating fund balance related to the closeout of prior year funding for the Program, to provide \$2,887,768.41 to a Special Council Contingency account to be used for City Council Strategic Initiatives in Fiscal Year 2024-2025 and \$1,000,000.00 to a Council President Contingency account.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to use remaining dollars from the Program in Fiscal Year 2023-2024 and General Fund dollars to provide \$2,886,768.41 to fund a portion of the City Council Strategic Initiatives for Fiscal Year 2024-2025 as outlined in Ordinance 2024-164-E and \$1,000,000.00 to fund a variety of initiatives in Fiscal Year 2024-2025.

Section 3. Carryover. The funds appropriated herein shall not lapse but shall carryover to fiscal year 2024-2025.

Section 4. Requesting One Cycle Emergency Passage Pursuant to Council Rule 4.901 Emergency. One cycle emergency passage of this legislation is requested. The nature of the emergency is to allow the Council to deliberate and take action on this appropriation contemporaneously with the Finance Committee commencing its review of the Fiscal Year 2024-2025 budget. During the budget review, the Finance Committee is expected to discuss and make recommendations regarding the Fiscal Year 2024-2025 City Council Strategic Initiatives and other Council initiatives that are proposed to be funded by this appropriation.

Section 5. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
