These locations include, but are not limited to, portions of Belfort Road, Bowden Road, Spring Park Road, De Kalb Avenue, Abby Lane, Cactus Lane, Cooper Circle West, Rodney Lane, Taylor Street, Glen Mawr Road, and Merwin Street. Upon completion of the improvements, the City will be responsible for the operation, maintenance, and repair of the improvements.
