4 **ORDINANCE 2023-502-E**

5 AN ORDINANCE LEVYING CALENDAR YEAR 2023 ANNUAL  
6 TAXES ON REAL AND PERSONAL PROPERTY LOCATED IN  
7 THE CITY OF JACKSONVILLE, INCLUDING ONLY THE  
8 SECOND, THIRD AND FOURTH URBAN SERVICES  
9 DISTRICTS, TO WIT: THE CITIES OF ATLANTIC BEACH,  
10 NEPTUNE BEACH AND JACKSONVILLE BEACH; STATING  
11 THE PERCENTAGE CHANGE FROM THE 2023 ROLLED-BACK  
12 RATE; AUTHORIZING ASSESSMENT AND COLLECTION;  
13 PROVIDING FOR THE USE OF THE REVENUES GENERATED;  
14 PROVIDING AN EFFECTIVE DATE.

16 **WHEREAS**, the City of Jacksonville entered into interlocal  
17 agreements with the cities of Atlantic Beach, Jacksonville Beach and  
18 Neptune Beach in 1995, 1996 & 1998, respectively, which established  
19 the millage rates as the difference between the City of Jacksonville's  
20 General Services District's millage rate and 3.2907 mills; and

21 **WHEREAS**, this Ordinance establishes the millage rates for the  
22 cities of Atlantic Beach, Jacksonville Beach, and Neptune Beach in  
23 accordance with the Interlocal Agreements with these respective  
24 cities and Chapter 200, *Florida Statutes*; now therefore

25 **BE IT ORDAINED** by the Council of the City of Jacksonville:

26 **Section 1. Ad Valorem Tax Levy - General Services**  
27 **District, Including Only the Second, Third and Fourth Urban Services**  
28 **Districts (The Beaches).** In accordance with Chapter 200, *Florida*  
29 *Statutes*, and the Interlocal Agreements between the City of  
30 Jacksonville and the cities of Atlantic Beach, Jacksonville Beach,  
31 and Neptune Beach, for the year 2023 there are hereby levied upon all

1 taxable real and personal property located within the General Services  
2 District of the city, including only the Second, Third, and Fourth  
3 Urban Services Districts (the cities of Atlantic Beach, Jacksonville  
4 Beach, and Neptune Beach), for county purposes, ad valorem taxes  
5 expressed in terms of mills on each dollar of assessed taxable  
6 valuation in the amount of 8.0262 mills, or \$8.0262 per \$1,000  
7 assessed taxable value.

8 **Section 2. Percentage Change From the Rolled-Back Rate.**

9 The 2023 operating millage rate levied herein by the Consolidated  
10 City of Jacksonville upon property within the General Services  
11 District of the city, including only the Second, Third, and Fourth  
12 Urban Services Districts, represents a 9.44% increase from the 2023  
13 rolled-back rate set forth in Resolution 2023-500-A, which is the  
14 amount agreed upon in the Interlocal Agreements between the City of  
15 Jacksonville and the cities of Atlantic Beach, Jacksonville Beach,  
16 and Neptune Beach.

17 **Section 3. Assessment and Collection.** The Property

18 Appraiser of the county is authorized and directed to assess, and the  
19 Tax Collector of the county is authorized and directed to collect,  
20 pursuant to law, the ad valorem taxes levied in this Ordinance.

21 **Section 4. Use of Revenues.** The revenues raised by the ad

22 valorem taxes levied in this Ordinance shall be utilized in the manner  
23 and for the purposes specified in the 2023-2024 budget and  
24 appropriations ordinance.

25 **Section 5. Effective Date.** This Ordinance shall become

26 effective upon signature by the Council President.
