

## **TYRIE WILLIAM BOYER**

On January 2, 2012, Tyrie W. Boyer was appointed to serve as a Circuit Judge after serving as a County Judge from January 2, 2001. He was elected Administrative Judge in 2007. By special appointment he also served as an associate judge on the First District Court of Appeal. Prior to the judiciary, he specialized in complex litigation (primarily product liability) and was one of our state's original Florida Bar Board Certified Civil Trial Lawyers — certified in 1983, and recertified in 1988, 1993, 1998, 2003, 2008, 2013, 2018 and 2023. He was also certified by the National Board of Trial Advocacy and enjoys an “AV” (the highest) rating by Martindale Hubbell. Since retiring he has become a certified mediator and a trained arbitrator. As a Judge, Boyer was a frequent lecturer at judicial conferences and is on the faculty of The Florida College of Advanced Judicial Studies. Additionally, he is the past chairman of two major Florida Bar committees — Professional Ethics as well as the Civil Procedure Rules Committee. Before becoming a Judge, Boyer was a founding member of the Jacksonville Chapter of the American Board of Trial Advocates and served as President in 1992. In 2016, he was honored by all of the State of Florida Chapters of ABOTA as “Jurist of the Year.” Previously, in 2015, he was named “Jurist of the Year” for the Fourth Judicial Circuit by Jacksonville's ABOTA Chapter. He is listed in multiple “Who's Who” publications (including Who's Who in America and Who's Who in American Law) and served as an adjunct professor at the Florida Coastal School of Law. Tyrie Boyer received his B.S. and his J.D. degrees from the University of Florida (where he served as Student Body President) and began practicing law in 1976.
