5 AN ORDINANCE APPROPRIATING \$280,117.66 IN  
6 COMMUNITY DEVELOPMENT BLOCK GRANT DISASTER  
7 RECOVERY ("CDBG-DR") FUNDS RECEIVED FROM THE  
8 U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT  
9 THROUGH THE STATE OF FLORIDA, DEPARTMENT OF  
10 ECONOMIC OPPORTUNITY, ORIGINALLY APPROPRIATED  
11 BY ORDINANCE 2022-165-E, FROM THE COMMUNITY  
12 DEVELOPMENT GRANT FUND FORGIVABLE LOANS ACCOUNT  
13 TO FUND SALARIES AND BENEFITS FOR FOUR FULL-TIME  
14 EQUIVALENT (FTE) POSITIONS WITHIN THE CDBG-DR  
15 PROGRAM, AS INITIATED BY B.T. 22-123; APPROVING  
16 POSITIONS, AS INITIATED BY R.C. 22-185;  
17 PROVIDING AN EFFECTIVE DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2022-2023 fiscal year,  
21 within the City's budget, there are hereby appropriated the indicated  
22 sum(s) from the account(s) listed in subsection (a) to the account(s)  
23 listed in subsection (b):

30 (c) Explanation of Appropriation:

31 The funding above is an appropriation of \$280,117.66 in

1 Community Development Block Grant Disaster Recovery  
2 ("CDBG-DR") funds from the U.S. Department of Housing and  
3 Urban Development ("HUD"), through the Florida Department  
4 of Economic Opportunity, originally appropriated by  
5 Ordinance 2022-165-E for forgivable loans, to allocate said  
6 funds for salaries and benefits for four full-time  
7 equivalent (FTE) positions within the CDBG-DR program.

8 **Section 2. Purpose.** The purpose of the appropriation in  
9 Section 1 is to allocate funds from the Community Development Grant  
10 Fund Forgivable Loans Account to pay salaries and benefits for four  
11 FTE positions within the CDBG-DR program. This action will alleviate  
12 the need to reallocate monthly salaries between grants which promotes  
13 sound reporting and minimizes opportunities for processing errors.

14 **Section 3. Approval of Positions.** There are hereby  
15 approved the four FTE positions within the CDBG-DR program as more  
16 fully described in R.C. 22-185, attached hereto as **Exhibit 2** and  
17 incorporated herein by this reference.

18 **Section 4. Effective Date.** This Ordinance shall become  
19 effective upon signature by the Mayor or upon becoming effective  
20 without the Mayor's signature.
