provide additional funding to KHA for summer camp programming as described herein.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide additional funding from the City to KHA for summer camp programming in fiscal year 2024-2025. These additional funds will allow an additional 980 students to be accommodated in summer camps over a 28-day period at the cost of \$25 per student, per day.

Section 3. Amending Third Revised Schedule M to Ordinance 2024-511-E. The Kids Hope Alliance fiscal year 2024-2025 budget approved by Ordinance 2024-511-E is hereby amended by substituting in the place of the Third Revised Schedule M, the Fourth Revised Schedule M, attached hereto as Exhibit 2 and incorporated herein by this reference, to reflect the funds appropriated herein.

Section 4. Oversight Department. The Kids Hope Alliance shall oversee the project described herein.

Pursuant to Council Rule 4.901 Emergency. Emergency passage upon introduction of this legislation is requested. The nature of the emergency is that the Council would like to ensure the funds appropriated herein are made available as soon as possible to ensure the funds are in place to accommodate the additional students prior to the commencement of summer camp programming.

Section 6. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
