Dear President Salem and Members of City Council:

In accordance with Jacksonville Municipal Code, Sections 380.605 transmitted herewith is an application for a Non-Residential Solid Waste Collection and Transportation Franchise application from Five Talent Services, LLC.

The Department of Public Works, Solid Waste Division has coordinated a review of the information submitted by the applicant, inspection of its facility and Jacksonville office location in addition to conducting telephone interviews with the applicant to discuss its existing and proposed operations and maintenance plan for expansion into Duval County and their business plan and marketing strategies to accomplish this expansion. The application was submitted with the appropriate fee of \$1,500.

Experience and Potential Significant Amount of Duval County Business –Five Talent Services, LLC. dba Mobiledumps of Jacksonville is a franchisee under the umbrella of a national franchise, Mobiledumps. The applicant has experience collecting, hauling, and disposing of various types of debris. Based upon skills and work ethic the applicant is certain the professional relationships built over the years with top management in Jacksonville will garner business. Mobiledumps is enthused about opening a business in Jacksonville with its ever-growing job market and population.

Financial Resources

The applicant certifies that it has the financial resources to perform its duties and obligations as a franchise. The applicant is starting a new business. The owner has submitted a balance sheet with equity in excess of \$100,000. The applicant's certificate of insurance has been reviewed by Risk Management staff and meets the specified insurance requirements.

Disposal Methods, Quantities, and Facilities

The applicant proposes to landfill all Class I franchised waste it collects at the City's Trail Ridge Landfill and estimates it will collect approximately 20 tons per month or 240 tons per year of solid waste.

The applicant's corporate headquarters are located at 708 Middle Branch Way, Saint Johns, FL 32259 with a local office at 11231 Phillips Industrial Drive E., Jacksonville, FL 32216 where their Duval County records can be examined.

Evidence of Safety and Reliability and Sanitation

The applicant will begin operations with brand-new equipment; one pickup truck and three dump trailers. All equipment is currently under warranty and well-maintained.

Background Information

The applicant has certified that it has not been adjudicated in default on any government contracts or bids and that there are no unsatisfied final money judgments against it.

Based upon the information received and reviewed, the Department recommends that the Council grant a franchise for a Non-Residential Solid Waste Collection and Transportation Franchise to Five Talent Services, LLC, dba Mobiledumps of Jacksonville based upon the following conditions:

- 1. execution of a franchise agreement as specified in Section 380.605(a) (6)
- 2. submission of a payment bond, as specified in Section 380.608(f)
- 3. execution of an indemnification agreement, as specified in Section 380.608(h)

- G. Any misrepresentation of information provided in the application shall be cause for suspension or revocation of the franchise.
- H. The franchisee shall deliver to the Department of Public Works, Solid Waste Division, a certified true and correct monthly report of gross receipts generated during the previous month from accounts within the City on or before the last day of each month along with a check made payable to the City in

the amount of 17% of the franchisee's previous month's gross receipts. (Report Form will be provided by the Department).

- I. The franchisee shall submit annual audited financial statements in accordance with 380.608 (b) (2) (i) by an independent certified public accountant licensed to do business in the state.
- J. If the franchisee becomes insolvent or files a petition of voluntary or involuntary bankruptcy, its franchise shall terminate no later than the date of filing of the bankruptcy petition.

Item 9: Five Talent Services - DBA: Mobiledumps of Jacksonville is a legally formed LLC in the state of Florida. Jason Fike is the owner/operator and owns 50% of the business. Cathleen Fike owns the other 50% of the business. We did file forms 8832 and 2553 so the LLC is treated as a S-Corp for tax purposes. See attached Sunbiz info.
