# Presentation on JUMP (Jacksonville Upward Mobility Program) - John Everett, KHA

John Everett, Director of Workforce Development for Kids Hope Alliance and JUMP, gave a presentation on JUMP.

He explained that unemployment, wage disparities, housing unaffordability, and gentrification can be results of economic development's out-pacing workforce development. He explained that the goal of JUMP is to ensure workforce development among Jacksonville's residents. He stated that many social programs geared at setting up young people for success cut off at age 18 despite the community's knowledge that early adulthood is one of the most important periods of an individual's life in ensuring that he/she is an active and contributing member of society. Various barriers to employment can hold individuals back during this period, and JUMP's goal is to remove these barriers. He noted that there was significant opportunity cost to not investing significantly in workforce development in the community.

Council Member Freeman stated that JUMP was in large part a re-imagining of the Job Opportunity Bank program, sponsored by former City Council President Kevin Hyde. He stated that Office of Economic Development programs should be connected with the goal of workforce development and reiterated that many social programs geared at young people cut off at age 18.

Council Member Boylan asked where JUMP was in terms of launching its programs. Mr. Everett explained that JUMP had programs through Goodwill, Lutheran Social Services, and Krumpin 4 Success that should be launching this month. Council Member Matt Carlucci asked how many people these programs should reach and how JUMP will go about identifying people to receive services through these programs; Mr. Everett answered that these programs should reach about 1,700 people and that outreach to school and afterschool programs as well as through non-profit and faith-based organizations helps to identify people who would benefit from services. Council Member Matt Carlucci agreed that many young people do not know what path they desire to take in life at age 18 and that the City should be supporting young people systemically in identifying their life path. He stated that he believed that there would be further opportunities for workforce development funding and voiced support for the program.

# **DEFER**

Council Member Boylan explained that Council Member Peluso had requested deferral so that he could focus more energy on educating the community on the contents of the bill after the Council had completed discussions on the Jaguars bill.

Council Member Freeman opined that the several deferrals of this bill showed that it was "not ready for primetime" and stated that he would be in support of either withdrawing the bill or discharging the bill so that the Council could vote on it this legislative cycle.

Council Member Johnson stated that the bill was not deferred due to its not being "ready for primetime." He stated that Council Member Peluso desired to defer the bill until after the discussions on the Jaguars bill had been completed.

Council Member Matt Carlucci stated that it would be bad precedent to withdraw a bill without the bill's primary introducer present. He stated that the bill should be deferred until after final action on the Jaguars bill to give the bill time to be understood by the public. Council Member Clark-Murray agreed and stated that the Council had a full plate at this point in time.

Council Member Boylan explained that it can be difficult to understand and explain to constituents the extent to which the City is investing in community services due to the piecemeal nature in which these investments are made and due to the variety of sources from which the funding is derived. He asked Travis Jeffery, Chief of Housing and Community Development, to explain the various community development bills before the Committee.

Travis Jeffrey stated that the Housing and Community Development Division receives five different grants, four federal and one state. He stated that they put out applications for various organizations to apply for funds, rank and score applications, and propose funding amounts for Council review.

Robert Ownby, Neighborhoods Property Administrator, explained the Foreclosure Registry funding and the programs that received funds. Council Member Clark-Murray asked about the specifics of the services that are funded through Foreclosure Registry funds, and Mr. Ownby answered that statute dictated that these funds be spent on foreclosure diversion and counseling efforts; community outreach and blight removal programs; the Jacksonville Assistance and Relief Program, which ensures that low-income and disabled residents are not burdened with nuisance liens; administrative costs; and community and neighborhoods outreach programs, including the CommUniverCity Program.

Council Member Boylan asked who oversees these blight removal efforts, and Mr. Ownby answered that these efforts are overseen by the Municipal Code & Compliance Division.

Phillip Peterson of the Council Auditor's Office explained the amendment, which was unanimously approved by the Committee.

Council Member Miller explained the bill. He explained that the new requirement for projects approved by the Tree Commission that cost in excess of \$300,000 to require Council approval would benefit visibility and transparency to the community of these projects. He stated that he did not believe that this requirement would present any impediment to the work of the Tree Commission.

Council Member Lahnen asked how many projects would require Council approval under this new bill, and Council Member Miller answered that three Tree Commission projects over the past two years have exceeded \$300,000.

Council Member Clark-Murray asked whether this requirement would significantly delay Tree Commission projects, and Justin Gearhart, a City arborist, answered that it would not. Mary Staffopoulos of the Office of the General Counsel stated that it would add a six-week delay to these projects as a result of going through the Council legislative cycle. Nina Sicker, Chief of Public Works, stated that this would not be a significant hindrance to the work of the Tree Commission but that developers would need to be aware of the requirement to ensure that their projects could be completed in the right conditions.

Council Member Boylan asked about the fund balance of the separate Tree Funds. Mr. Peterson answered that this bill would bring the balance of the BJP Tree Fund to zero, would bring the Charter fund to \$10.4 million, and would bring the Ordinance fund to \$7.6 million. Council Member Boylan confirmed with Council Member Miller that the appropriations of this bill would not significantly burden the balance of overall tree funds in the City. Council Member Miller added that the Tree Commission manages the balances of these funds carefully. Council Member Boylan asked how quickly these funds get replenished; Mr. Peterson answered that he could not give a specific answer to the question but that they do get replenished through development. He answered that the replenishment of these funds had been slowing down as a result of development going down (the overall balance of the fund has been up to \$30 million, and these appropriations would bring the balance to around \$18 million). Mr. Peterson explained the different project categories and how they receive funding.

Council Member Matt Carlucci asked whether any of these dollars go to tree installation for commercial development. Mr. Peterson explained that they did not and explained the different "levels" of projects. Council Member Carlucci stated that he asked this question because commercial developers often do not plant trees correctly, resulting in trees that never grow, and that he would likely soon be introducing legislation to address this problem.

Tiffany Pinkstaff of the Office of the General Counsel explained the bill. She stated that the bill involved a dispute, which was still ongoing, regarding the One Riverside Avenue Project, a multi-use project with Whole Foods planned as the "anchor tenant." She explained that the developer of this project has alleged that the City's delay in its construction of the McCoy's Creek relocation portion of the project has impacted its ability to complete its portion of the project in a timely manner. The bill authorizes the City to amend the McCoy's Creek Improvements project as a result of mediated discussions between the City and the developer and to cap damages paid by the City.

Council President Salem asked whether Downtown Investment Authority ("DIA") was in support of the bill. Lori Boyer, CEO of DIA, stated that she was limited in what she could say, as litigation was still ongoing, but that DIA was not opposed to the terms of the bill.

Council President Salem stated that it was bad precedent to borrow money to appease a developer and that he would like to see the funding source changed so that the City was not taking out any debt as a result of this bill. Phillip Peterson of the Council Auditor's Office explained that the entire loan could become forgivable but that the Council did have options to fund the bill besides debt. Anna Brosche, City CFO, stated that the administration was open to using other funding sources for the bill.

Council President Salem moved an amendment to use General Fund Reserves instead of debt funds, and Council Member Lahnen seconded the amendment, noting that the City would be paying interest on this debt. Council Member Matt Carlucci asked whether DIA supported the amendment, and Ms. Boyer stated that DIA had no opposition to the amendment. The amendment was unanimously approved by the Committee.

Phillip Peterson of the Council Auditor's Office explained the emergency, and it was unanimously approved by the Committee.

Mr. Peterson explained the amendment and the Auditor's concern listed on the agenda. Council Member Johnson stated that he did not believe the amendment to be necessary, as the bill directly appropriated funds to an organization and was not a grant. He explained that these funds were specifically carved out for mental health programs and that the Safety and Crime Reduction Commission requested that the bill be passed as an emergency as the organization to receive funds provided services through a summer camp and that these services were time-sensitive. Mr. Peterson explained that the distinction between grant and direct appropriation was semantics and that the amendment was still necessary to clarify reporting requirements.

Council Member Clark-Murray asked why the bill advanced the funds to this organization, and Council Member Johnson stated that it was necessary to fund the hard costs that the organization would incur to activate the program this summer. Council Member Lahnen asked whether all of the funds would be spent by the summer's end, and Council Member Johnson answered that they would be.

Council Member Boylan requested that Mr. Peterson re-explain the amendment, which Mr. Peterson affirmed was still necessary. The amendment was passed by the Committee.
