7 AN ORDINANCE APPROPRIATING \$200,000 FROM THE
8 COUNCIL PRESIDENT'S DESIGNATED CONTINGENCY TO
9 THE HOMELESSNESS INITIATIVES SPECIAL REVENUE
10 FUND TO PROVIDE ADDITIONAL FUNDS FOR VARIOUS
11 PROGRAMS, INITIATIVES, AND SERVICES FOR DUVAL
12 COUNTY'S HOMELESS AND/OR CHRONICALLY UNHOUSED
13 POPULATIONS; PROVIDING AN EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
17 within the City's budget, there is hereby appropriated the indicated

2 unhoused populations.

3 **Section 2. Purpose.** The purpose of the appropriation in
4 Section 1 is to provide additional funding to support various
5 programs, initiatives and services for Duval County's homeless and/or
6 chronically unhoused populations. The Council is providing these
7 funds with the desire that it be used for specific programs or
8 services recommended by the Homelessness Initiatives Commission
9 recently created by Ordinance 2024-111-E.

10 **Section 3. Effective Date.** This Ordinance shall become
11 effective upon signature by the Mayor or upon becoming effective
12 without the Mayor's signature.
