AN ORDINANCE APPROVING THE PROPOSED 2024B SERIES TEXT AMENDMENT TO THE CONSERVATION AND COASTAL MANAGEMENT ELEMENT AND INFRASTRUCTURE ELEMENT OF THE 2045 COMPREHENSIVE PLAN OF THE CITY OF JACKSONVILLE TO ADOPT BY REFERENCE THE STATE MANDATED TEN (10) YEAR WATER SUPPLY FACILITIES WORK PLAN, FOR TRANSMITTAL TO THE STATE OF FLORIDA'S VARIOUS AGENCIES FOR REVIEW; PROVIDING A DISCLAIMER THAT THE AMENDMENT GRANTED HEREIN SHALL <u>NOT</u> BE CONSTRUED AS AN EXEMPTION FROM ANY OTHER APPLICABLE LAWS; PROVIDING AN EFFECTIVE DATE.

Section 1. Approval of Amendment for Transmittal Purposes. The Council hereby approves the proposed 2024B Series Text Amendment to the Conservation and Coastal Management Element and Infrastructure Element of the 2045 Comprehensive Plan as set forth in Exhibit 1, attached hereto, dated November 12, 2024, and Exhibit 2, attached hereto, dated November 2024, for transmittal to Florida's various required State Agencies for review.

Section 2. Disclaimer. The amendment granted herein 1 2 shall **not** be construed as an exemption from any other applicable 3 local, state, or federal laws, regulations, requirements, permits or 4 approvals. All other applicable local, state or federal permits or approvals shall be obtained before commencement of the development 5 or use and issuance of this amendment is based upon acknowledgement, 6 7 representation and confirmation made by the applicant(s), owner(s), developer(s) and/or any authorized agent(s) or designee(s) that the 8 9 subject business, development and/or use will be operated in strict 10 compliance with all laws. Issuance of this amendment does not approve, 11 promote or condone any practice or act that is prohibited or 12 restricted by any federal, state or local laws.

13 Section 3. Effective Date. This ordinance shall become 14 effective upon the signature by the Mayor or upon becoming effective 15 without the Mayor's signature.
