> The funding above is an appropriation of \$100,000 from the Special Council Contingency to the General Fund Operating Salaries Overtime account within the Jacksonville Sheriff's Office ("JSO") to provide funding to JSO for overtime salaries for the provision of security services

at the Sulzbacher Center.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funds to cover overtime salaries for JSO officers to provide security at the Sulzbacher Center located at 611 E. Adams Street, Jacksonville, Florida 32202. The Sulzbacher Center has requested this service because of recent incidents that have occurred outside of their facility raising security concerns for the individuals who are served by the Sulzbacher Center and the employees who work at the center.

Section 3. Carryover. The funds appropriated herein shall not lapse but shall carryover to fiscal year 2025-2026.

Section 4. Requesting One Cycle Emergency Passage Pursuant to Council Rule 4.901 Emergency. One cycle emergency passage of this legislation is requested. The nature of the emergency is to allow the security services to commence as soon as possible recognizing the Sulzbacher Center has already experienced employee turnover due to the incidents that have occurred outside the facility.

Section 5. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
