ORDINANCE 2025-100

AN ORDINANCE APPROPRIATING \$500,000 FROM A GENERAL FUND OPERATING DESIGNATED CONTINGENCY ACCOUNT TO THE GENERAL FUND OPERATING SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORG ACCOUNT, TO PROVIDE CITY GRANT FUNDING TO WE CARE JACKSONVILLE, INC. ("WE CARE JAX") TO SUPPORT THE JAXCARECONNECT PROGRAM (THE "PROGRAM") AS DESCRIBED HEREIN; PROVIDING FOR CARRYOVER TO FEBRUARY 28, 2026; WAIVING SECTION 118.107 (NONPROFITS TO RECEIVE FUNDING THROUGH A COMPETITIVE EVALUATED AWARD PROCESS), PART 1 (GENERAL PROVISIONS), CHAPTER 118 (CITY GRANTS), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH WE CARE JAX FOR THE PROGRAM; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF THE CITY A GRANT AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND WE CARE JACKSONVILLE, INC. FOR THE PROGRAM; WAIVING THE CONFLICTING PROVISIONS OF SECTION 118.805 (ELIGIBILITY TO APPLY FOR PUBLIC SERVICE GRANTS), PART 8 (PUBLIC SERVICE GRANTS), CHAPTER 118 (CITY GRANTS), ORDINANCE CODE, TO ALLOW WE CARE JAX TO REMAIN ELIGIBLE TO APPLY FOR FUNDING FROM OTHER CITY GRANT PROGRAMS FOR THE PROGRAM; PROVIDING FOR OVERSIGHT BY THE GRANTS AND CONTRACT COMPLIANCE DIVISION OF THE FINANCE DEPARTMENT; PROVIDING AN EFFECTIVE DATE.
