The purpose of this budget transfer is to aid in the funding of the McCoy's Creek Improvements project that includes, but is not limited to, closing and removing most of McCoy's Creek Boulevard, restoring McCoy's Creek, constructing a multi-use path and multiple cul-de-sacs and sidewalk connections, and replacing and raising two bridges that cross over McCoy's Creek. Deferral of this appropriation would result in the City of Jacksonville not receiving needed grant funds.
