

Business Impact Estimate

AN ORDINANCE APPROPRIATING \$125,000 FROM THE MULTIYEAR PROGRAMS AND INITIATIVES – COUNCIL DISTRICT 14 COMMUNITY BENEFITS AGREEMENT - CONTINGENCY ACCOUNT TO THE KIDS HOPE ALLIANCE FUND – ESP – OUT-OF-SCHOOL-TIME – SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORG ACCOUNT TO PROVIDE FUNDING TO VISION FOR EXCELLENCE, INC. (“VFE”) FOR THE SUMMER AND AFTER SCHOOL DISCOVERY EXPERIENCE PROGRAM (THE “PROGRAM”) AS DESCRIBED HEREIN; PROVIDING FOR CARRYOVER TO FISCAL YEAR 2026-2027; AMENDING THE THIRD REVISED SCHEDULE M TO ORDINANCE 2025-511-E; WAIVING CERTAIN REQUIREMENTS OF SECTION 77.111 (CONTRACTS; CONTRACT ADMINISTRATION; CARRYOVER), CHAPTER 77 (KIDS HOPE ALLIANCE), *ORDINANCE CODE*, TO EXEMPT THE SERVICES TO BE PROVIDED BY VFE FROM COMPETITIVE PROCUREMENT; WAIVING SECTION 110.112 (ADVANCE OF CITY FUNDS; PROHIBITION AGAINST), PART 1 (THE CITY TREASURY), CHAPTER 110 (CITY TREASURY), *ORDINANCE CODE*, TO ALLOW FOR A PARTIAL ADVANCE PAYMENT TO VFE UP TO AN AMOUNT NOT-TO-EXCEED \$31,250; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY, AND/OR THE CHIEF EXECUTIVE OFFICER OF THE KIDS HOPE ALLIANCE (“KHA”) TO EXECUTE AND DELIVER ON BEHALF OF THE CITY AN AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND VISION FOR EXCELLENCE, INC. FOR THE PROGRAM; PROVIDING FOR OVERSIGHT BY KHA; REQUESTING ONE CYCLE EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.
