4 **ORDINANCE 2022-721-E**

5 AN ORDINANCE CLOSING AND ABANDONING AND/OR  
6 DISCLAIMING AN OPENED AND IMPROVED PORTION OF  
7 THE COLLINS FIELD WAY RIGHT-OF-WAY, ESTABLISHED  
8 IN THE PLAT OF SANDLER LAKES, AS RECORDED IN  
9 PLAT BOOK 75, PAGES 9-14 OF THE CURRENT PUBLIC  
10 RECORDS OF DUVAL COUNTY, FLORIDA, IN COUNCIL  
11 DISTRICT 12, AT THE REQUEST OF KB HOME  
12 JACKSONVILLE LLC, SUBJECT TO RESERVATION UNTO  
13 JEA OF AN ALL UTILITIES, FACILITIES AND ACCESS  
14 EASEMENT; PROVIDING FOR APPROVAL SUBJECT TO  
15 CONDITIONS; PROVIDING AN EFFECTIVE DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Closure and Abandonment.** An opened and improved  
19 portion of the Collins Field Way right-of-way, established in the  
20 Plat of Sandler Lakes, as recorded in Plat Book 75, Pages 9-14 of the  
21 current public records of Duval County, Florida, located in Council  
22 District 5, a depiction and description of which is attached hereto  
23 as **Exhibit 1** and incorporated herein by this reference, is hereby  
24 closed and abandoned and/or disclaimed as a right-of-way at the  
25 request of KB Home Jacksonville LLC, (the "Applicant"); provided  
26 however, there is reserved unto JEA an all utilities, facilities and  
27 access easement on, over, under, through and across the closed right-  
28 of-way for ingress and egress and for all utilities and facilities,  
29 including but not limited to, water, sewer and electric, so as to  
30 provide JEA continued access to repair and maintain these utilities  
31 and facilities. The Applicant paid the right-of-way closure

1 application fee of \$2,091.00 and this amount has been deposited into  
2 the General Fund. This closure request was reviewed and approved by  
3 the various city, state, and utility agencies that might have an  
4 interest in the right-of-way and there were no objections to the  
5 Applicant's request.

6 **Section 2. Purpose.** The Applicant owns property adjacent  
7 to the closure area (see R.E. No. 015450-1010 for locational purposes)  
8 and is requesting the closure to create two additional single family  
9 lots within its Sandler Lakes development, subject to the conditions  
10 set forth herein.

11 **Section 3. Hold Harmless Covenant.** The closure and  
12 abandonment by the City of its interests in the right-of-way is  
13 subject to Applicant's execution and delivery to the City of a Hold  
14 Harmless Covenant, in substantially the same form attached hereto as  
15 **Exhibit 2** and incorporated herein by this reference. Accordingly,  
16 the closure and abandonment of the right-of-way shall not be recorded  
17 in the public records until execution and delivery to the City by the  
18 Applicant of the required Hold Harmless Covenant.

19 **Section 4. Effective Date.** This Ordinance shall become  
20 effective upon signature by the Mayor or upon becoming effective  
21 without the Mayor's signature.
